# LOCAL NEIGHBOURHOOD PLAN AND CONSULTATION

Councillor Madeley introduced the report.

John Beavon referred to the local plans which had been produced by the Local Committees and suggested that they could be used to provide information to feed in to the Local Neighbourhood Plan. He added that detailed consultation would be carried out to ascertain the needs of the area to include in the plan.

After further discussion it was:-

#### Resolved

That the partnership:-

- (1) adopts the proposed approach to consultation and producing the first plan as outlined in the report now submitted;
- notes the timescales for producing, approving and subsequently reviewing the first plan;
- notes the standard template (attached as an appendix to the report now submitted) for producing the plan;
- (4) sets up a sub-group consisting of Councillor s Madeley and Chambers and the PCT representative to consider the local neighbourhood plan.

# LOCAL NEIGHBOURHOOD PARTNERSHIP – SUMMER CLEAN UP

7/04 A report was submitted:-

(see annexed)

Councillor Madeley referred to the Ward Walks which members had undertaken with the Chief Executive to highlight problem areas at which it had resulted in a number of areas being improved. He indicated that the Summer Clean Up would provide the focus for a quick success and the Local Authority would assist with the provision of refuse sacks, litter pickers and gloves. The Local Authority would also dispose of the litter after the event. He suggested that the town centre and the linear walkway should be the subject of the clean up.

Mr. Clarke (Head Teacher representative) expressed concern that, because of the timing of this first event, children and teachers from Darlaston Schools could not be involved.

Bryan Pell suggested that, following on from this initial clean up, a second event should be held in the Autumn when school children and teachers could take part.

Mr. Clarke commented that, if young people were involved, then ownership of the project would be re-enforced and littering might be reduced.

It was suggested that a sub-group should be set up to consider an Autumn Clean Up campaign once locally appointed partners had been appointed.

After further discussion it was:-

#### Resolved

- (1) That the Summer Clean Up should target the town centre and linear walkway;
- (2) That a sub-group be set up to consider an Autumn Clean Up once locally appointed partners have been appointed so that school children and teachers can be involved:
- (3) That local companies/organisations be invited to sponsor litter bins for future events.
