I am a specialist licensing officer, based at Lloyd House, Police Headquarters.

This statement is in relation to a summary review for the premises licence that trades as 'Valeshas Nighclub' (Valeshas) in Walsall. Tragically, a young man, Akeem FRANCIS-KERR was murdered inside the venue in the early hours of Saturday 11 March 2023.

The licence reference is WS/PRL/0242 and the address of the premises is 17 Newport Street, Walsall, WS1 1RZ.

Walsall Council has confirmed that the Premises Licence Holder transferred the Premises Licence from his own name into the name of a 'partnership' called 'Capital Leisure' in July 2022. The Premises Licence holder prior to the transfer was Mr Sukhbir Singh Samra.

I am also aware from an email sent to Walsall Licensing from Mr SAMRA on 30th November 2022 that Mr SAMRA had drawn up a lease agreement with a company called Vision Leisure Limited (Company number 14412371) which was incorporated on 11 October 2022.

The directors of Vision Leisure Limited being Valesha Andrea ANDERSEN and Martin BELL who both run Valesha's night club on the ground floor and a lap dancing venue situated in the upstairs first floor of 17 Newport Street known as Savannah's Gentlemen's Club (which holds an additional Sex Entertainment Venue). Access to both clubs are available to customers internally via a staircase.

Vision Leisure Limited (Company number 14412371 and incorporated on 11 October 2022 - it has has two directors: Valesha Andrea ANDERSEN and Martin BELL) has a tenancy agreement with the Premises Licence Holder - Capital Leisure.

Capital Leisure is owned as a partnership with Mr Suky SAMRA being the owner however, I have not seen any documentary evidence to confirm that this partnership exists, its purpose or its members. Mr SAMRA is a councillor for Walsall Borough covering the Streetly ward, he is also a member of the Licensing Committee.

With the fast pace of the murder investigation and the enquiries that are taking place, I have only been able to review limited parts of CCTV and evidence relating to this case. Some of these matters cannot yet be disclosed for highly sensitive operational reasons.

I have been able to view some footage from the premises which I describe below.

From the footage I have observed, what stands out to me is that some of the suspects are granted entry to the premises shortly after 04:00. They do not queue like other customers, they are not searched (in breach of a licence condition), they simply walk in and shake hands with door security members in a familiar manner, as if the door security members recognise them.

At approximately 05:00, Akeem FRANCIS-KERR aproaches the venue with a friend. The front door is closed. They knock on the door and make a phone call. At the same time, a member of security unlocks the door from the inside to allow a customer out. At this point, Mr FRANCIS-KERR and his friend gain entry to the venue.

Several minutes later the disorder takes place.

Mr FRANCIS-KERR is escorted out of the bar area by security staff with what turned out to be a fatal injury. He is escorted whilst standing up, and walking backwards, as if he is being ejected. When he gets to the cloak room, staff must realise that he is seriously injured and administer first aid. The offending group are not ejected by security at this time.

I am Jennifer Mellor 60384 currently based at Walsall	Police Station as the Walsall Licensing and
Regulatory Services Officer. This statement has been	written to assist with the Summary Review of the

Premise Licence WS/PRL/0242 Valesha's Nightclub formally known as the Coliseum.

As part of my licensing duties I visited the Coliseum to introduce myself to the new tenants on Tuesday 6th December 2022. I attended with Sarah Heath-Marshall, Community Protection Officer at Walsall Council. Present was Valesha ANDERSEN, Martin BELL directors of Vision Leisure Limited and Dion Lewis the Designated Premise Supervisor at the time. From the conversation this was a new venture for BELL and ANDERSEN as neither had or have venues elsewhere.

I was informed the ground floor would be renamed to Valesha's Nightclub which has a capacity of 350 persons. There would be a strict dress code, no trainers, man bags, caps hoodies etc. All glassware would be polycarbs and bottles decanted. Although they have a licence until 8am of the morning, they agreed to a last entry policy of 04:30 hours, the front door would be closed from this point. They would aim to be closed as a venue on this floor around 6am unless they had customers spending money in the club and would remain open until 8am. Come next Feb/March they would be looking to run student nights on a Tuesday night.

The first floor which has the benefit of a Sexual Entertainment Licence would be renamed Savannah's Gentleman Club, this has a capacity of 150. This floor would also have a last entry policy of 04:30 hours. They were hopeful of attracting customers from outside of Walsall. They would look to close this floor off at 6am unless they had customers spending with the girls. Glassware would be used in this area. There will be a "no touch" policy with the girls and this area is covered by CCTV.

They confirmed all their cameras had been upgraded for clearer images. The SIA door team would be from UK bodyguards who would be provided with bodycams, they would also be suited and smart.

Statement of Jennifer Mellor

I fully explained the lack of police after 5am of a weekend and that they seriously needed to consider the safety of their staff and customers should they trade after these times. They further advised they are looking for upmarket customers and from what they had seen in Walsall during the NTE, most customers would not be allowed in their venue.

On 10th January 2023 I attended again with Sarah Heath-Marshall. Present was ANDERSEN director of Vision Leisure Limited and now the Designated Premise Supervisor, and Daniel MORRIS their manager at the time. During the meeting they asked for the removal of the 04:30 last entry policy. I strongly felt it was too soon to be making changes in policy when they had only been open for a matter of weeks. Furthermore they had not be running to their maximum capacity to ensure they had robust policies in place. After being repeatedly asked by MORRIS to the point of annoyance I, out of fairness agreed to speak with the Area Neighbourhood sergeants for their decision.

I received a telephone call from MORRIS confirming the continuation of the 04:30 last entry policy for a further 3 months until the end of March 2023 after they had time to reflect on the conversation. This was also confirmed in a later conversation with ANDERSEN.
