The New Local Area Agreement (LAA) – Review and Refresh

1. Summary of report

- 1.1 The new LAA was approved by Council on 19. May 2008, subject to further negotiations delegated to the Chief Executive, and received Ministerial approval on 30. June 2008. The Agreement contains 25 main indicators and 5 local indicators against which Government will measure our progress for CAA purposes and to determine the level of performance reward grant paid.
- 1.2 At sign-off targets for 16 of the main indicators were either deferred for technical reasons or because Walsall had indicated reservations with regard to the level of improvement expected by Government in the light of the economic conditions at the time.
- 1.3 This report sets out the position going into the process of reviewing and refreshing the new LAA and negotiating targets for the outstanding indicators.

2. Recommendations

- 2.1 That Cabinet note the stages involved in the review/ refresh process;
- 2.2 That Cabinet note the issues that are likely to form the subject of negotiations with Government Office over the coming months;
- 2.3 That Cabinet delegates negotiations to the Chief Executive, in consultation with the Leader and that progress is reported back to future Cabinet meetings.

3. Background Information

3.1 Appendix 1 sets out all new LAA indicators. Where there is an entry in the final column the reasons why targets have not been set or where they are likely to be reviewed have been identified. They include:

- Indicators which rely on the results of the Place Survey for baseline and target setting,
- Other indicators where target setting was deferred, often because baseline data was not available,
- Indicators where targets were set but in the knowledge that further technical guidance was to be issued,
- Indicators where Walsall raised the need to revisit agreed targets at the time of sign-off, mainly as the risk of recession increased,
- Local indicators where Walsall is still to propose a definition or target
- 3.2 Two additional issues still need to be formally resolved:
 - NI 167 Congestion: Walsall is fully signed up to relevant regional strategies and the Local Transport Plan, but Government Office West Midlands (GOWM) have asked the Audit Commission to make an assessment of whether the non-inclusion of the indicator in the LAA is likely to affect implementation,
 - NI 35 Building resilience to violent extremism. GOWM have received Walsalli's draft community cohesion strategy and have indicated that they are reassured PVE is a very important priority for the partners.
- 3.3 A further issue that could emerge over the coming months is the possibility of adding an indicator relating to services provided to disabled children (probably NI 54). Information has been received that this is a pre-requisite of the Council being able to sign up to the 'every disabled child matter charter'. Further investigations are being made with regard to this information and into complexities around the measurement of the indicator.

3.5 A detailed action plan will be agreed with Government Office in the next few weeks but is essential that each deliverable is approved by Cabinet, as the responsible Local Authority, the Strategic Partnership and Pillar structures relevant to individual indicators and targets.

4. Resource considerations

4.1 Financial

- 4.1.1 Council and partners will be expected to align mainstream activity to deliver the indicators and priorities identified in the LAA in support of the vision and ambitions for Walsall which are contained in the Sustainable Community Strategy.
- 4.1.2 It is likely that Area Based Grant also will be closely aligned to activity to deliver the indicators and targets identified in the LAA although the process by which this will managed is still being considered.

4.2 Legal

4.2.1 The LAA is being driven locally by the Local Strategic Partnership but requires approval of the Council as the Responsible Local Authority.

4.3 Staffing

4.3.1 There are no direct staffing considerations arising from this report.

5. Citizen impact

There are a number of potential LAA indicators that will have a direct impact on citizens.

6. Community safety

There are a number of potential LAA indicators that will have a direct impact on community safety.

7. Environmental impact

There are a number of potential LAA indicators that will have a direct impact on the environment.

8. Performance and risk management issues

- 8.1 Delivery of LAA targets will have a direct impact on the Council's rating under the new Comprehensive Area Assessment arrangements.
- 8.2 Performance of the new LAA targets will be managed through the structures of the LSP with assistance from the Council's Corporate Performance Management Unit.

9. Equality implications

Where appropriate equalities will be measured across each indicator selected for the LAA. A requirement will be included in the Target Action Planning process that will ensure that data is collected on the equalities impact of all activity.

10. Consultation

LAA development has been driven by Walsall Partnership and therefore has been subject partner involvement throughout.
