Children's Services Overview and Scrutiny Committee

The Education Overview and Scrutiny Committee met on 26 March 2019 and considered the following items:

Economy and Environment Overview and Scrutiny Committee

On 4 April 2019, Economy and Environment Overview and Scrutiny Committee considered the following:

Economy and Environment Financial Performance – Forecast Revenue and Capital Outturn Update for 2018/19

The Committee considered a financial performance update for the forecast revenue and capital outturn position for 2018/19 for services within the remit of the Committee.

Members requested clarification on implementations of Open Plus in Libraries, underachievement of planning applications, additional security works at clean and green depots and the active living grant allocation to Oak Park car park.

Areas of Focus - 2018/19

The Committee received an update from the Leader of the Council on proposal for Police and Crime Commissioner Governance transfer of powers to Mayor of West Midlands Combined Authority (WMCA). In response, he confirmed that the WMCA Board considered proposals and resolved to postpone implementation due to opposition from Board Members.

Following consideration of the WMCA Board Forward Plan for May 2019 to July 2019, the Chair requested that the following reports be circulated to Members of the Committee for information:

- Adult Education Budget
- 5G Delivery Plan Update
- Low Emissions Strategy
- Strategic Bus Vision Delivery Plan

Air Quality in Walsall

The Committee received a presentation from Executive Director of Economy and Environment and Director of Public Health about the Council's overview of air quality in Walsall. In addition, the Committee received a presentation from

Assistant Director of Transport and Connectivity at Birmingham City Council on Birmingham's Clean Air Zone (CAZ).

The Executive Director, Director of Public Health and Head of Planning, Engineering and Transportation informed the Committee that overall human-made air pollution attributed between 28,000 and 36,000 deaths each year. Whilst the effects of the air pollution on human health had been significant, there was a direct correlation with air pollution affecting the vulnerable and deprived areas of society.

It was noted that the Council was working with Central Government, neighbouring authorities and partner organisations to identify and reduce air pollution in the Borough.

A few highlights:

- Sustainable Travel: Active, Responsible Safe (STARS) was an accreditation scheme for schools to encourage young people to travel to walk or cycle to school. The Executive Director encouraged Members to engage with local schools about the STARS initiative;
- The West Midlands Air Quality Improvement Programme established by Birmingham University aimed at understanding pollution in the region and develop ways of improving public health;
- The West Midlands Low Emissions Towns and Cities Programme involved all West Midland Local Authorities to conduct technical feasibility studies on low emission zones and health and economic impacts. The programme resulted in the establishment of a low emissions vehicle strategy;
- The Council recognised the role of electric vehicles in reducing air pollution in the Borough;
- It was noted that the West Midlands Combined Authority was developing a Low Emissions Strategy.

Economy and Environment Draft Annual Report

The Committee consider the Economy and Environment draft annual report which sets out the work by the Committee for the period 2018/19.

The Chair was disappointed that the Air Quality Working Group had not been established this year. However, he praised the positive work that the Committee had completed especially with the Private Rented Sector Housing and Selective Licensing Working Group.

Petition: Compulsory purchase of the former Legge's Site and any other site surrounding the Town Centre to help regenerate Willenhall.

The Committee considered a petition in Private Session on compulsory purchase of the former Legge's Site and any other site surrounding the Town Centre to help regenerate Willenhall. Councillor D Coughlan presented the petition and explained her reasons for the use of compulsory purchase powers in Willenhall.

Executive Director – Economy and Environment explained the role of CPOs and circulated a briefing note to Committee Members.

It was noted that negotiations were ongoing with the landowners and partners to purchase the former Legge's site.

The Committee resolved to note the petition.
