In relation to the performance side of the report, Members wished to congratulate Officers for their hard work and for exceeding Government targets.

Members then sought additional information on some of the outstanding enforcement cases.

In relation to Boundary Court, 35 – 49 Boundary Road, Streetly – The Committee's Solicitor and the Head of Planning and Building Control advised Councillor Douglas Maul on the latest position with regard to this case and agreed to provide further information to him outside the meeting.

With reference to 110 Bridle Lane, Streetly – The Head of Planning and Building Control agreed to write urgently to the applicant advising that the next step the Council would be undertaking was to instigate prosecution.

During the discussion, the Committee requested that the Head of Planning and Building Control send a suitably worded letter, to be agreed by Legal Services, to Breweries in the area advising them of the implications of illegal car washes being allowed to use their land, in a hope that providing accurate information on the proper process and requirements for setting up such a business lawfully would lead to prevention rather than cure.

Furthermore, at the request of the Chair and Vice-Chair, the Head of Planning and Building Control agreed to refer this and the following enforcement reports as well as any future cases that may arise to the Head of Public Protection for her to investigate if prosecution can be undertaken on Public Protection Grounds as a result of the drainage of chemicals.

The Chair, at the beginning of each item for which there were speakers advised of the procedure whereby the speaker would have three minutes to speak and then at two minutes they would be reminded that they had a minute left.

2116 /09 Item No. 4 - 09/0502/FL - change of use from newsagents (A1) to chip shop (A5 hot food take-away) at 305 Wolverhampton Road, Walsall, WS2 8RL

The Planning Officer advised the Committee of the background to the report and drew Members' attention to the additional information and condition contained within the supplementary paper now submitted.

The Committee then welcomed Mr. Jones who spoke in support of the application.

The Committee then welcomed Mr Poonian who also spoke in support of the application.

There then followed a period of questioning by Members in relation to the location of the lay-by and bus stop in relation to the shop, the type of ventilation to be used and its location, the affect of the red routeproposals on parking along the road in question and whether the car park to the rear of the shop could be tidied up as a part of the conditions.

The Committee proceeded to discuss the application in detail.

Members considered the application and Councillor Pitt **moved** and it was duly **seconded** by Councillor Bird:-

That planning application No. **09/0502/FL** be approved subject to the conditions as contained in the report now submitted, and subject to condition 8 of the permission requiring it to be implemented before the business is in use.

The motion having been put to the vote, was declared carried, with 16 members voting in favour of granting planning permission and 1 against.

2117 /09 Item No. 5 - 09/0331/FL - change of use to restaurant and take-away (Use Class A3 and A5) (No external changes) at Day Street, Walsall, WS2 8EJ

The Planning Officer advised the Committee of the background to the report and drew Members' attention to the additional information as contained within the supplementary paper now submitted.

The Committee then welcomed Mr. Single who spoke in support of the application.

The Committee then welcomed Mrs. Gilbert who also spoke in support of the application.

There then followed a period of questioning by Members in relation to the need for such a business in the area, whether the new ring road had eased traffic problems, the class use of a nearby Subway restaurant, where the Gigaport would be in relation to the application site, the relationship between this site and the new college and demand that may arise from students, evidence of any traffic problems or accidents in the vicinity of the application site, parking restrictions, siting of local car parking spaces and the suitability of the location in relation to the Town Centre.

The Committee proceeded to discuss the application in detail.

Members considered the application and Councillor Robertson **moved** and it was duly **seconded** by Councillor Ault:-

That planning application No. **09/0331/FL** be approved, subject to detailed conditions in relation to the usual time limit on implementation, grease trap, extraction and filtration system; litter bins and waste disposal systems, and appropriate signage being displayed on the premises to advise on parking opposite the site, being approved by officers as the Committee were of the opinion that there was no likelihood of parking problems from on-street parking, sufficient off-street parking in the vicinity of the application site and felt that there had been a significant change in the demographics of the area leading to a business need that would serve the local community and would therefore not be detrimental to the vitality of the town centre.

The motion having been put to the vote, was declared carried with 14 members voting in favour of granting planning permission and 3 against.

2118/09 Item No. 6 - 09/0458/FL - two 98 sheet posters on a monopole at Axletree Way (Adj. Ikea entrance) Wednesbury, Walsall

The Planning Officer advised the Committee of the background to the report.

The Committee then welcomed Mr George who spoke in support of the application.

There then followed a period of questioning by Members in relation to the location of the proposed sign in relation to the existing sign, the size of the signs in relation to other signs in the Borough and if there was any evidence to support an increase in traffic accidents as a direct result of signs distracting drivers.

The Chair and Vice Chair reminded the Committee that it could only consider this application on Highway Safety grounds, if they agreed with officers that as recommended, there was no objection to the amenity aspects of it. In view of this it was down to Members to consider the concerns raised by the Highways Agency and weigh up if they agreed that the signs would be dangerous by way of causing drivers to divert their attention at this point on the Motorway or not. The Chair also reminded the Committee that this application was different to other similar applications that had previously come before the Committee as an Active Traffic Management system was being proposed on this section of the M6 which the sign would be adjacent to.

The Committee's Solicitor also advised the Committee to base its decision purely on the recorded objections of the Highways Agency and not to attach any weight to the fact that there was not a representative from the Highways Agency present at the meeting. The Committee proceeded to discuss the application in detail.

Members considered the application and Councillor Pitt **moved** and it was duly **seconded** by Councillor Rochelle :-

That advertisement application No. **09/0458/FL** be refused as detailed in the report now submitted.

At this juncture in the meeting, the Chair stated that he would like a named vote on this motion.

The Clerk advised the Committee that paragraph 18.5 of the Council's Procedure Rules stipulated that 5 of the Members present at the meeting must call for a named vote in order for a named vote to take place.

In view of this advice, the Chair sought 5 members to agree to a named vote on this motion.

Councillors Pitt, Douglas - Maul, Rochelle, Underhill and Turner duly obliged and requested a named vote on the motion.

The motion having been put to the vote, was declared lost with members voting against the refusal of permission as follows: -

In view of the motion failing, the Chair sought the Committee intentions on how to proceed with this application. Members again considered the application and Councillor Ali **moved** and it was duly **seconded** by Councillor Ault:-

That advertisement application No. **09/0458/FL** be approved as the Committee felt that the sign would not be a distraction to drivers and taking into consideration the full concerns of the Highways Agency and the proposed Active Traffic Management and its proximity to the slip road, Members felt that there was insufficient road safety evidence to refuse permission.

The motion having been put to the vote, was declared carried with 10 members voting in favour of granting permission and 6 against.

Resolved

That advertisement application No. **09/0458/FL** be approved as the Committee felt that the sign would not be a distraction to drivers and taking into consideration the full concerns of the Highways Agency and the proposed Active Traffic Management and its proximity to the slip road, Members felt that there was insufficient road safety evidence to refuse permission.

Councillor Barton left the room for a short period during the consideration of this item and therefore did not take part in the deliberations and did not vote.

At the conclusion of this item, Councillor Bird moved, and it was duly seconded by Councillor Cook, that Standing Order No. 9 of the Council's Procedure Rules be suspended to enable the Committee to determine the remainder of its business. The Committee supported this motion unanimously.
