Purpose of the report: To inform Schools Forum of the allocation of the centrally

retained Primary School to School Support Contingency

Funding for 2011-12.

To discuss with the Schools Forum the potential distribution of

this element of the former Primary National Strategy Grant

funding in 2012-13.

Recommendation: Schools Forum is recommended to agree the proposals

contained within section 4 of this report.

1. Introduction

- 1.1 During the 2011-12 budget setting process the Schools Forum agreed to retain £248.5k, plus two smaller sums for Nursery and Special schools from the Primary National Strategy Grant, to support schools facing significant challenges and therefore at risk of not making sufficient pupil progress to secure a favourable Ofsted inspection outcome. The funding would provide support to such schools in order to accelerate improvements in their educational outcomes.
- 1.2 The initial proposal made to Schools Forum was to retain £421k for schools of concern in respect of all schools. However, secondary school representatives opted to have their proportion of the funding included in their delegated budgets. The Primary Forum supported the supportive initiative subject to an early review of the process in December 2011.
- 1.3 This report presents the outcome of the review process by Primary headteacher colleagues.

2. Outcome of the Review

- 2.1 In the 2011-12 financial year eleven schools received an allocation of £4.5k from the £248.5k centrally retained sum. At a recent meeting of the Primary Forum a decision was taken that the balance of funding, approximately £199k should be returned to primary, nursery and special schools for the following reasons:
 - Mixed reviews of support packages
 - Per pupil funding is progressively weighted towards schools with high levels of deprivation
 - Pressure on primary school budgets due to Equal Pay and Single Status

However Primary headteachers stated that they would review this issue again prior to the start of the next financial year.

2.2 Attached to this report at Appendix 1 is a summary of the allocation of the remaining School to School Support Contingency funding to the eligible schools. These payments will be made to schools as part of their delegated budget allocations during the remainder of the 2011-12 financial year.

3. 2012-13 Funding Arrangements

3.1 The Primary Forum did say that they would revisit the retention of School to School Support prior to the start of the forthcoming financial review. However, the new school funding system is gearing up for maximum delegation of funds to all schools, thereby mirroring the Academy funding system for maintained schools. It will be difficult to operate such "safety net" approaches in the future. Schools facing significant challenges will be required to buy appropriate support from the LA or an alternative provider as and when required.

3.2 The new funding reforms will also introduce a more simplified approach to school funding and therefore it is recommended that the £248k retained centrally in 2011-12 is allocated to the eligible primary, nursery and special schools via the AWPU factor or hourly rate for maintained nursery schools.

4. Recommendations

- 4.1 Schools Forum is asked to note the views of the Primary Forum and the allocation of approximately £200k to eligible primary, nursery and special schools.
- 4.2 Schools Forum is asked to consider the delegation of this funding to schools through the AWPU factor or hourly rate for maintained nursery schools with effect from 1 April 2012.
