## Schools Forum

Schools Forum Membership

## 1 Purpose of Report

To ensure that Schools Forum membership complies with Schools Forum (England) Regulations 2012 and that members and stakeholders feel that membership is fit for purpose.

2 Recommendations
2.1 That Walsall Schools Forum notes that no change in schools membership is required and no change in non-schools membership is proposed.
2.2 That membership will next be reviewed in July 2017.

## 3 Background

3.1 The Schools Forum Regulations 2012 state, "An authority may determine that the number of members representing schools in a particular school category must be broadly proportionate to the total number of schools in that category when compared with the total number of schools."
3.2 Legal advice has not been sought with regards to the word 'may' but Walsall Schools Forum has been operating on the principle that membership is split on the basis of pupil numbers in each group from Reception to Year 11. The split is between the defined groups of maintained secondary, maintained primary and academy. The split is also analysed on a primary and secondary basis.
3.3 With Primary, Nursery and Special Forum and WASH electing members to attend Schools Forum in September and a Chair elected in September, it has been viewed as logical that a membership review would need to take place in July 2016 to be implemented in September.

4 Proposal - Primary, Secondary and Academy Membership
4.1 As detailed in Section 3 membership should be broadly proportionate to pupil numbers. The following three tables analyse pupil numbers in slightly different ways. Table 1 is in line with School Forum Regulations. Table 2 breaks academies into primary and secondary phases. Table 3 does not differentiate between maintained schools and academies and looks only at phase.

4.2 Based on continuing with 17 members, the optimum split which would be fair not only under DfE regulations, but based on all three tables is in line with current membership.
4.3 Clearly if there was a decision to alter the total number of members that would alter the various splits which are outlined in the tables in 4.1 above.
4.4 Obviously if there is any further academy conversion the numbers will once again change.

There are no financial or value for money implications.

6 Legal Implications
The numbers of members representing schools in a particular school category continues to be broadly proportionate to the total number of schools in that category when compared with the total number of schools.
