## **Apologies**

#### **Presentation**

Ms. Jeet Sohal of the Sikh Forum gave a brief presentation outlining the Sikh religion which was founded by Guru Nanak who was born in 1469. There had been nine Gurus after Guru Nanak. With regard to the history of the Khalsa, this was created by the ninth Guru in 1699 by Guru Gobind Singh Ji, effectively the birthday of the Sikh religion and he baptised all the other Gurus.

### The Khalsa includes:

- Work hard Kirt Karo
- Share your food/earnings with those less well off than you Vand Shako
- Meditate on God's name Naam Jappo
- Believe in one Guru EK-ON-KAR
- Believe the holy scriptures to be our living Guru

A baptised Sikh wears the five K's – Kanga, Kesh, Karra, Kirpan and Kaccha and has to pray five times a day.

Members thanked Ms. Sohal for her presentation.

## **Draft annual report**

The draft annual report was submitted:

Mr. Taylor outlined the content of the draft annual plan and asked members to check the content of the report and, in particular, to provide information to be included in paragraphs 7.1, 8, 9 and 10. Any additional information or amendments be submitted to Constitutional Services by 30th November 2007, in order that they can be included in the final report for submission to Education Walsall and to Walsall Council.

It was suggested that with regard paragraph 8, links with NASACRE, multi-faith forum, Churches together and the Council could be included. With regard to paragraph 9, one of the major issues related to attendance at the meeting by representatives of the Christian and other religious denominations group on SACRE. With regard to paragraph 10, SACRE meet three times a year in public session. SACRE had appropriate sub-groups and committees to carry out actions approved by SACRE and there was a financial arrangement with Education Walsall in respect of initiatives to support RE. SACRE had agreed arrangements for monitoring the use of the Agreed Syllabus in schools and those taking part had undergone training.

#### Resolved

That the draft annual report be approved, subject to the inclusion of additional information set out above at the paragraphs indicated, together with any other information that members may wish to submit.

### **Update on monitoring of the Agreed Syllabus**

The report of Constitutional Services was submitted:

Mr. Taylor informed SACRE that the schools to be visited had yet to be determined and letters advising of the visits would be forwarded to those schools nearer to the date of the visits. Head Teachers would be contacted personally to be given an explanation on the purpose of the visit and unions would be informed of those schools to be used as a pilot with the proposal to roll out the visits.

### Resolved

That SACRE note that visits to schools by SACRE members, together with appropriate officers would commence during December 2007/January 2008.

## Proposed local conference seminar – progress

Mr. Taylor informed SACRE that it would need to request his participation in a planning group for the conference and to produce an itinerary and financial plan. After consideration of arrangements for the conference it was:

#### Resolved

- (1) That the conference take place on either the 26th September or 3rd October 2008 at the Bethell Centre, Kelvin Way, West Bromwich, subject to availability.
- (2) That Mr. Taylor be authorised to make the arrangements with the Bethell Centre for the conference and to contact other local authorities in the Black Country inviting them to take part in the event.
- (3) That David Taylor be provided with information relating to possible speakers and that a decision be taken by the sub-group in accordance with the urgent action procedure.
- (4) That members wishing to suggest issues for discussion forward them to Constitutional Services by 30th November 2007.
- (5) That investigations take place into the possibility of teachers from "outstanding" schools to run the workshops at the conference.
