SCHOOL FORUM REPORT 3RD DECEMBER 2013

FOREST ARTS MUSIC SERVICE (Walsall Music Hub)

- 1) Please reference, as necessary, the two previous reports submitted to Schools Forum.
- 2) Walsall Primary schools continue to have mutuality with Forest Arts Music Hub through the "Wider Opportunities" agendas, which all Primary schools can access. The Secondary music agenda has been greatly enriched by Forest Arts facilitating MusE, the collegiate group of all Walsall Secondary Music Teachers working in collaboration with the Music Hub. This initiative has been recognised by Headteachers as a powerful exemplar of subject specific support, challenge and development; both anticipating and addressing recommendations in the recent Ofsted report for Music.

The retention of Music Hub status for Walsall is predicated on regular statistical report back to DfE regarding the levels of music education achievement for all schools. Forest Arts Service has been praised for the management of the data trawl system, and Walsall schools have been recognised for their high levels of musical engagement. This is testament to the embedded partnership arrangements that presently exist and have been in place for many years. These positive arrangements will be further *road-tested* by the implications of the Ofsted report "Music in Schools: What Hubs Must Do".

Statistical Headliners include:

- 8,874 pupils receive weekly music tuition through Forest Arts Service
- There are 296 regular ensembles across Walsall providing choral and instrumental rehearsal and performance opportunities for at least 5,100 young people.
- 3,105 primary pupils receive first access whole-class teaching support, of which 1,647 elect to
 continue in *pathway* groups. This represents a continuation of 53%, which is in the highest
 quartile nationally.
- Forest Arts provides evening Music Centres on Monday, Tuesday and Wednesday throughout the school year, with additional opportunities during the Summer Holiday.
- 2,161 pupils achieved exam success in grades 1-8 (NQF Levels 1-3) during 2012/13
- Inclusion for all young people who wish to participate in music remains a key driver and significant numbers of pupils with socio economic challenges, SEN and vulnerable pupils receive support to include bespoke provision.
- 3) The previous submissions to Schools Forum have identified the drop in the Arts Council (ACE) grant, with the final step reduction being effective from 1st April 2014.

The incremental reduction in government funding places further pressure on the required economy of scale which enables the Music Team to sustain core functionality and maintain the diverse portfolio of school delivery services. The ramification for not securing support funding from Schools Forum adds additional strain to the potential budget shortfall arising from these external grant reductions.

5) Forest Arts Service requests a continuation of support funding from Schools Forum, this would lessen the impact of the reduced government grant. There will be the need for ongoing remodelling of the music delivery to come within budget and still safeguard the broad curriculum portfolio and access to music for young people in Walsall. The mechanisms for additional efficiencies are still under assessment and planning.

If approved, School Forum funding would be utilised to support quality music provision and ensure adequate instrumentation is available in diverse forms for the benefit of young people in Walsall.
