66. Apology

71. **Petitions**

72. Petitions

(a) Community Alarm service

A report was submitted.

Ms. A. Jarvis presented the petition stating that the community alarm service was an essential service to many vulnerable individuals. The service allowed them to live independently and with dignity. She confirmed that many of the service users would be unable to afford to pay for a replacement service. Many service users were on low incomes and using foodbanks. Ms Jarvis emphasised that a significant proportion of service users were long term disabled and many others were vulnerable. She stressed that the community alarms service was a life-saving service that should not be cut to make savings. In closing, she urged for the cut to be reconsidered.

Further to debate on the matter it was:

Resolved

That the report and petition be noted.

(b) Streetly Police resources

A report was submitted, together with a statement from West Midlands Police.

Mr. D. Erfani presented the petition emphasising that response times to Streetly from stations in Wolverhampton and Bloxwich were unacceptable. He stated that the police needed to be located closer to Streetly to be able to respond more quickly. He noted that Streetly was a cross border authority and urged those authorities to work together and to improve the CCTV provision to deter criminal activity. He stated that a private security group had approached him to offer assistance but he had not accepted such proposals.

Further to debate on the matter it was **moved** by Councillor Shires and seconded by Councillor Barker and:

"Would the appropriate Portfolio holder inform me, this Council and the general public as to whether Walsall Council has made any assessment of the likely impact of "Brexit" on local authorities such as Walsall and if so could the portfolio holder briefly outline the key finding of such an assessment, particularly highlighting the opportunities that have been identified that Brexit may offer to local authorities such as Walsall, that are not available presently due to E.U legislation obligations?"

Councillor Bird replied stating that the Council would meet the challenges as they arise. He referred to a written response setting out the Councils preparations including emergency planning, equalities, human resources, community cohesion and finance, procurement and contract matters and provided Mr. Smith with the same.

(3) That Council delegates authority to the Executive Director Economy and Environment, in consultation with the Portfolio Holder for Regeneration, to make further minor modifications to the SAD and AAP prior to their final publication, provided these are edits in respect of such matters as referencing, formatting and typographical errors, and these do not include any material changes to policy wording that might affect the soundness of the plans.

81. Notice of motion - Universal Credit

A report was submitted.

The following motion, notice of which had been duly given was **moved** by Councillor S. Coughlan and seconded by Councillor Jeavons:

Council agrees that the intention of Universal Credit (UC) to make benefits less complicated and to allow those in low paid work to keep more of their wages is a good idea, but believes that the evidence demonstrates that the Universal Credit process is flawed and causing unnecessary hardship to local families.

Council notes that UC was deliberately introduced on a slow rollout so that any issues could be seen and corrected before the benefit was introduced to all claimants.

Council further notes that the evidence of this Council and others across the country is that UC is causing huge increases in rent arrears and in general debt levels amongst claimants, many whom have never been in debt before. In addition, evidence demonstrates that most private landlords and even some housing associations are refusing to accept tenants receiving UC, leading to an increase in those registering as homeless and seeking temporary accommodation.

Council therefore resolves to write to the Secretary of State for Work and Pensions, making these points, requesting that the Government addresses these issues, and that the rollout is halted until the problems are fixed.
