The Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012

Specified pecuniary interests

The pecuniary interests which are specified for the purposes of Chapter 7 of Part 1 of the Localism Act 2011 are the interests specified in the second column of the following:

| Subject | Prescribed description | |

| Employment, office, trade, profession or vocation | Any employment, office, trade, profession or vocation carried on for profit or gain. | |
| Sponsorship | Any payment or provision of any other financial benefit (other than from the relevant authority) made or provided within the relevant period in respect of any expenses incurred by a member in carrying out duties as a member, or towards the election expenses of a member. | |
| | This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Regulations (Consolidation) Act 1992. | |
| Contracts | Any contract which is made between the relevant person (or a body in which the relevant person has a beneficial interest) and the relevant authority: | |
| | (a) under which goods or services are to be provided or works are to be executed; and | |
| | (b) which has not been fully discharged. | |
| Land | Any beneficial interest in land which is within the area of the relevant authority. | |
| Licences | Any licence (alone or jointly with others) to occupy land in the area of the relevant authority for a month or longer. | |
| Corporate tenancies | Any tenancy where (to a member's knowledge): | |
| | (a) the landlord is the relevant authority; | |
| | (b) the tenant is a body in which the relevant person has a beneficial interest. | |
| Securities | Any beneficial interest in securities of a body where: | |
| | (a) that body (to a member's knowledge) has a place of business or land in the area of the relevant authority; and | |
| | (b) either: | |
| | the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or | |
| | (ii) if the share capital of that body is more than one class, the total nominal value of the shares of any one class in which the relevant person has a beneficial interest exceeds one hundredth of the total issued share capital of that class. | |
