Strategic Priority 4: Reduce the level of ASB and increase the level of satisfaction with how ASB is dealt with in the Borough

Strategic Activity

Partnership activity is on-going in relation to tackling ASB across the Borough. We have a very effective Area Tasking process whereby partners meet monthly and discuss ASB and Crime issues. Those meetings are fed by a detailed analytical document containing hotspot analysis and ASB complaints determined from data provided to the WIN by all partners. Outside of those meetings there is very effective partnership working and robust ASB case management.


As you are aware new ASB powers came into effect on the 20th Oct and Safer Walsall Partnership invested heavily in its preparations. We have not had any ASB case reviews triggered and are looking to do some further communications regarding publishing our processes. In the autumn, one year on from the commencement of the new powers we intend to republish our Community Trigger Process, hold a Partnership Practitioners day to capture the learning thus far and lastly we would like to commission a public survey to investigate how we as a Partnership the public feel we deal with ASB.

Work on the implementation of the new tools and powers continues and we are focusing our efforts on moving swiftly towards a position where we will be able to utilise both Public Spaces Protection Orders and Community Protection Notices. We recently undertook our first consultation with Youth Justice Services on an a number of the new Civil Injunctions whg are seeking to obtain and are in the process of finalising consultation requirements around these orders which after some delay commenced on the 23 March 2015.



Total Number of Police Recorded ASB Incidents




Year to date, the Borough has had 1,714 ASB incidents, a 10.9 per cent reduction compared to the same period the previous year. Incidents have been above average since April 2015. Historically incidents have peaked during the summer months of June and July. We could therefore still expect to see a seasonal rise in incidents as a result of lighter nights, warmer weather and schools breaking up for the summer holiday.

Using year to date data, the below chart shows a number of hotspots across the Borough. With the exception of Pheasey, the highest intensity of incidents can be seen within the Priority Areas.




Walsall Borough ASB Incidents 1st April – 30th June 2015


Year to date, AP3 has had 434 ASB calls for service compared to 526 during the same period the previous year. This equates to a decrease of 17.5 per cent. ASB incidents during the months of April and May 2015 were above average however, June 2015 saw a reduction to 127 incidents which is below average. In 2014, June (197 incidents) and July (194 incidents) were peak months and were above the Upper Control Limit.

Customer Satisfaction with Service in Relation to ASB

Customer Satisfaction with service in relation to ASB has continued to increase since April 2015. Current performance is 80%



Every month West Midlands Police survey people who have reported ASB and ask them a series of questions. Walsall continues to maintain high levels of overall satisfaction. The Partnership may wish to consider commissioning a bespoke Walsall survey to seek the views of its residents as to how they feel we work in Partnership to tackle ASB especially now that we have introduced new practices. We would recommend that we explore this option one year on from the introduction of the new powers.

Challenges Ahead and Future Reporting

As has already been mentioned we have new tools and powers and an ASB Review Trigger Process which will assist us all working together more effectively to tackle ASB in the Borough. The policies and procedures relating to these will be included in the Borough ASB Manual of Guidance; this is currently in draft form and will in effect become the ASB Policy for the Borough ensuring that all agencies work collectively to tackle ASB in a consistent fashion. Although as a borough we are well placed regionally in respect of this work there is still further work to be undertaken and decisions to be made in relation to their implementation. To support this work each Area Panel was recently asked to express its view on the transitional arrangements in relation to the existing Designated Public Place Order (DPPO) and the new Public Spaces Protection Order. These views along with the recommendations of legal services will be considered and inform our decisions as we take this work forward. We will continue to keep the Board updated and it will be interesting to see what effect these new tools and powers have.

It is our intention to keep the Local Policing and Crime Board and the Safer Walsall Partnership Board fully up to date with our progress. This will include a report about ASB review cases conducted and the findings from them.


<u>Safer Walsall Partnership - Strategic Priority 3: Reduce the level of crime experienced in the Borough</u> <u>focussing particularly on those areas that have historically experienced higher levels (Priority Areas) -</u> <u>specific focus on Public Place Violence, Domestic Burglary and Business Crime.</u>

Strategic Activity.

Partnership activity is on-going in relation to reducing all crime across the Borough. Effective Control Strategies are employed against each crime type which have detailed activities in relation to prevention, intelligence, enforcement and reassurance and are directed at locations victims and offenders. The Police employ a very effective tasking and coordination process which involves monthly in depth analysis of crime, risk and threat, the production of a tasking document and a meeting where key decisions are made about planned activity and resource deployment. The Partnership employs a similar effective Area Tasking and Coordination process which also involves analysis and the production of a tasking document which supports a monthly tasking meeting involving Partners. Above all these processes sit a variety of Partnership working groups that seek to address particular themes for example: Integrated Offender Management, Domestic Violence, Troubled Families, Sex Worker Project, Retail Crime, Town Centre Ops group etc.




Total Recorded Crime (TRC)

TRC has increased this year, compared to the same time last year. Year to date we have recorded 4,398 offences compared with 3,981 offences at the same point last year. This equates to a 10.5% rise.




PPV has increased this year, compared to the same time last year. Year to date we have recorded 640 offences compared with 573 offences at the same point last year. This equates to an increase of 67 offences, a rise 11.7%.

Domestic Burglary




Burglary Dwelling has increased compared with the same time last year. Year to date we have recorded 253 offences compared with 174 offences at the same point last year. This equates to 77 more offences and an increase of 43.8%.



Business Crime


Business crime has increased this year compared with the same time last year. Year to date we have recorded 1,044 offences compared with 1,027 offences at the same point last year. This equates to an increase of 17 offences a rise of 1.7%



Violence with Injury (VWI)


Violence with injury has increased this year compared with the same time last year. Year to date we have recorded 552 offences compared with 492 offences at the same point last year. This equates to an increase of 60 offences, a 12.2% rise.

Domestic Abuse



Domestic Abuse crime has increased compared with the same time last year. Year to date we have recorded 468 offences compared with 426 offences at the same point last year. This equates to an increase of 42 offences a 9.9% rise.

Hate Crime



Hate Crime has increased compared with the same time last year. Year to date we have recorded 81 offences compared with 70 offences at the same point last year. This equates to an increase of 11 offences a 15.7% rise.

Total Recorded Crime

Borough context

Total Recorded Crime (TRC) in Walsall has been on a reducing trend over the last twelve years and total crime has almost halved since 2002/3 as shown below, from an average of 2407 to 1340 (equivalent to a 44.3% reduction).



Walsall recorded Crime since April 2002


The following table shows the breakdown of total crime by area partnership over the last two years. Willenhall/Short Heath is the only area to experience a overall reduction in TRC. North Walsall experienced a 7.5% increase in TRC; between Nov 2012-Oct 2013 (3,528) compared to Nov 2013-Oct 2014 (3,793).

Public Place Violence (previously measured as Violence with Injury)

Hotspot analysis of PPV/VWI between Nov 2013 – October 2014 shows that the main hotspot for PPV VWI is within Walsall Town Centre (Walsall South AP4), though the hotspot crosses marginally and at a low intensity level into Walsall South where it borders with AP4.



The table below shows that most areas have experienced an increase in offences over the 12 months compared with the previous period, the exception being Darlaston/Bentley. Numerically Walsall South and North Walsall experienced the greatest increases, although Aldridge/Streetly/Pheasey/Walsall Wood experienced the largest proportionate percentage increase.



Domestic Burglary


Borough context

There were 1056 recorded domestic burglary offences within the Borough between 1_{st} November 2013 and 31_{st} October 2014 compared to 1263 offences during the same period in the previous year, equating to a 16% reduction. The control chart below shows monthly performance since 2002, and how burglaries have reduced significantly throughout this time. The current average is 79 offences per month which is a 55% reduction on the monthly average in 2002/2003. More recently, good reductions were experienced between April and June 2014 before levels returned to similar levels experienced prior to April and have remained controlled.

All but one AP experienced reductions over the last year, with the only increase being on Darlaston/Bentley, with an increase of just 7 offences. The greatest reductions both numerically and as a percentage were on Aldridge/Streetly/Pheasey/Walsall Wood AP.

Business Crime


Borough Context

There were 4152 offences of Business Crime recorded across the Borough between 1_{st} November 2013 and 31_{st} October 2014, compared with 4039 during the same period in the previous year, equating to an increase of 3%. The chart below shows the monthly levels of recorded offences since November 2008, when records began. The reported increase this year compared to the previous period is mainly as a result of an increase in offences since May 2014, which was driven by an increase in Theft from Shops/Stalls.

Anti-Social Behaviour

Borough Context

There were 6480 recorded ASB incidents within the Borough between 1_{st} November 2013 and 31_{st} October 2014 compared to 5929 incidents during the same period during the previous year, which means there has been a 9.3% increase in offences (Police recorded ASB data only). Police recorded ASB incidents only make up approximately 42% of all recorded ASB across the Borough; over half of incidents are recorded by various agencies other than the police.


The chart below shows monthly levels of ASB since April 2010, when West Midlands Police changed incident recording classifications.



Walsall ASB incidents since April 2010

Over the long term, there has been a reduction from an average of 1212 incidents per month in 2010 to 517 per month over the last two years, equating to a 57% reduction in incidents. The increase in incidents this year compared to the previous year was mainly due to a rise in June and July 2014.

The following map shows that the main hotspot for ASB incidents is within Walsall Town Centre (Walsall South AP).



Hate Crime


Borough context

There were 256 Hate Crime offences recorded by the Police throughout the Borough between 1_{st} November 2013 and 31_{st} October 2014, compared to 234 in the previous year, equivalent to an increase of 9%. Recorded offences have been following an increasing trend over the last two years, as shown below. It is difficult to understand whether this increase is a result of more offences or whether there in an increase in confidence around reporting.

The following shows the highest intensity for hate crime offences is within Walsall Town Centre (Walsall South AP). There are small pockets of incidents within Walsall North AP3




















Jobseekers by neighbourhood




Breastfeeding Rates – 6 to 8 Weeks






Reception Year Children who are Overweight / Very Overweight: Rates

•The chart above shows there are some areas (in red) of North Walsall have high rates of children with excess weight – these include Mossley, Goscote and North Blakenall community areas.






Dementia Prevalence

- A practice in Leamore and a practice in North Blakenall have shown the biggest increase in Dementia cases.





- A practice in Leamore and a practice in North Blakenall have the lowest Diabetes prevalence rates.


