674/20 Resilient communities model

In attendance: Councillor G. Perry, Cabinet portfolio holder for

Communities, Leisure and Culture

A report to Cabinet on 18 December 2019 was submitted for information which outlined the high level service transition of the Resilient Communities model, its functions, form and delivery timetable:

Councillor Perry explained the background to the new model which was designed to enable and support people to have personal responsibility; to promote community led solutions; enable integrated services for the delivery of support to communities; and integrated enforcement actions. He stressed the partnership approach to this model, many of which were partners on the Health and Wellbeing Board.

Board members supported the model however, Mr P. Tully commented that there was significant synergy with the Resilient Communities component of the Walsall Together Programme and was concerned that this may lead to misunderstanding and duplication. In response, Mr Fradgley advised that he had had a conversation with Councillor Perry to ensure a consistent and coherent approach to the two largely complementary models and that they would continue to liaise together.

Resolved

That the Resilient Communities model presented be supported and that further progress reports be submitted to ensure alignment between this model and the Resilient communities component of the Walsall Together Programme; and that in the meantime, the two lead organisations continue to work together accordingly.

675/20 Walsall Plan – Improving the environment in Walsall Town Centre priority

Development

The report setting out progress against priority 3 of the Walsall Plan – Walsall Town Centre was submitted:

Mr Tranter gave a presentation providing an overview of the Council's Town Centre Masterplan, the aim of which was to have the healthiest high street in the Country. He stressed that 'Health' in this context was in the wider sense and included for example, the health of the economy, the cultural offer, the atmosphere and not just to food outlets.

Members discussed the report and presentation during which time, comments included:

- More key messages to be consistently provided to challenge and change behaviours of users of the Town Centre so that it is not further depressed.
- Potentially providing outlets for behaviours such as having a graffiti wall.
- The proposed number of electric car charging point is not ambitious enough.
- More could be done to link with the Canals and Rivers trust to ensure that canal towpaths were kept in reasonable condition to promote walking and cycling.
- That there were over 15 million public transport movements in Walsall each year and that there has been a programme of engagement activity with Town Centre users as any changes would impact upon those uses; however, this may only capture views of the usual willing contributors.

Ms Thompson responded to questions and points of clarification during which time she concurred that the functioning of equipment stores may lead to delayed discharges from hospital and that an inquiry had been launched accordingly.

- Included Domestic Abuse in its Walsall Plan priority Violence Reduction;
- Support and champion the Family Safeguarding and Walsall together models
- Support and champion the development of an all-age exploitation strategy
- Allow safeguarding partnerships to contribute to the JSNA refresh to help shape the needs of the most vulnerable in Walsall.

With regard to Domestic Abuse, Mr P. Walters offered the support of the Fire Service via its Safe and Well visits. Ms Holt mentioned that the college was being supported by the West Midlands Violence Reduction Unit to involve staff and students in their programmes. In addition she said that the Wolverhampton University was undertaking research into Domestic Abuse and would be hoping to share the outcome with the Safeguarding Board.

Dr Rischie commented that whilst there was an increased awareness in the community in relation to Domestic Abuse, there was a frustration from GPs that information was not being communicated to them. Ms. Murphy undertook to look into this.
