163/16 Void Properties Group

A briefing paper was submitted:-

The Head of Business Change (Paul Gordon) enlarged upon the briefing note for the benefit of the panel and indicated that the Council needed to take rapid action about properties which were considered dangerous. To speed up the process the Area Managers have been tasked with taking action over dangerous properties and co-ordinating any necessary action to secure sites and tidy up fly-tipping or drugs paraphernalia found on site with partner organisations and the owner/managing agents of the properties.

The Area Manager (Laura Terry) drew attention to a void property at Ravens Court, a mixed residential and commercial site. The property was open and had been used for drinking and drug taking and a lift shaft had also been accessed. Anti-social behaviour powers had been used to obtain immediate closure orders to secure doors, a lift shaft and access to the roof. This had been completed within two hours. However, the site has still attracted young people and within 24 hours the property had been breached again. The owners had now secured the building and tidied the site and a secure door had been fitted.

Councillor Perry referred to the void property group and suggested that the Fire Service should act as lead rather than Council officers. He referred to the fact that void properties had become a borough wide problem and often led to arson attacks.

Paul Gordon informed the panel that building control had not been called to attend the fire at a public house in Pelsall because the Council is only involved if six pumps or more attended the fire.

A local resident referred to the number of derelict garages throughout the borough which were the subject of arson attacks or used for drink/drug sessions. He asked if certain garage blocks could be repaired and the rest demolished to remove the problem.

Councillor Perry suggested that void properties should be included as a standard item on future agendas, and it was:

164/16 Youth Provider Support Update

Dan Garbett (Bloxwich Community Partnership) informed the meeting that he had been involved in youth work for 15 years in various parts of the borough. He indicated that the re-commissioned Youth Service was working well. He reported that street based working was carried out on three evenings a week in Pelsall and Shelfield/Rushall. He added that the Area Manager would provide the service with 'hot spots' then the team would go out and interview youngsters to ascertain their wants/needs. He drew the panel's attention to the summer programme undertaken in the boroughs' parks and added that the mobile provision (move truck) was very popular and helped build rapport with youngsters.

A local resident referred to the fact that youths tended to hang around Pelsall Library especially on Mondays when it was closed. She added that they did not cause trouble but simply hung around outside talking. She asked if the Youth Service worked in the late evening and at weekends. She added that skateboarders used the paved area and the car park at the library which could lead to conflict with pedestrians and motorists using the car park. Dan replied that if sites were identified then the service would try to respond within the restrictions imposed by limited funding. After further discussion if was:
