180/05 Standards Board for England – annual review

The Committee was advised that the Standards Board for England had produced its annual report reviewing its performance over the last 12 months. The Standards Board summarised its achieved objectives for the year 2004/2005 as:

- Clearing the backlog of 400 investigations
- Speeding up investigations, completing nearly twice as many as last year
- Halving the time taken to make decisions on whether to investigate a complaint
- Filtering out malicious, vexatious and tit for tat complaints
- Focusing on cases with the potential to damage local democracy

- Enabling successful local investigations
- Encouraging local authorities to take leadership on ethics
- Developing an ethical governance toolkit with the Audit Commission and the Improvement and Development Agency.

The Assistant Director of Legal and Constitutional Services explained in detail the report and referred to paragraph 8 of his report and said that it was a matter of concern that only 24% of complaints submitted to the Standards Board were referred for investigation. Mr. Gill said that the high level of rejection of complaints could have a negative impact on the level of public confidence in the system.
