## 3671 Direct payment support services tender

#### Resolved

(3) That Cabinet delegates authority to the Executive Director of Adult Social Care to agree a contract modification with existing providers for the period 6.10.17 up to 31.12.17 to allow for a 60 day transition between new and outgoing providers; should this be necessary.

- (2) That Cabinet delegates authority to the Interim Director (Change and Governance), to enter into contracts for the provision of Electrical White Goods, Residential Furniture and Floor Coverings for Crisis Support and to subsequently authorise the sealing of any deeds, contracts or other related documents for such services

## Summary of items considered in private session

#### 3675 Retail development and investment opportunity in Walsall Town Centre

The Cabinet considered a report which provided the detail of a proposed transaction and outcome of due diligence and which sought approval to enter into contracts. Cabinet:

- (1) approved, subject to Council approval of the amendment of the Capital Programme, the exchange of conditional contracts to facilitate a development opportunity in Walsall Town Centre.
- (2) delegated authority to the Executive Director for Economy and Environment in consultation with the portfolio holder for Regeneration to agree any variations in the terms of the transaction.
- (3) delegated authority to the Executive Director for Economy and Environment in consultation with the portfolio holder for Regeneration to enter into any contracts, deeds or warranties deemed necessary for the purchase of the property and initial continued maintenance.
- (4) recommended to Council that it approves a variation to the Capital Programme accordingly.
- (5) noted the arrangements needed in relation to the tax of site and buildings with HM Revenue and Customs.

## 3676 New Art Gallery: Arts Council England grant offer and management options

The Cabinet considered a report which set out a number of options available to the Council in relation to the future arrangements for the management of the New Art Gallery. Cabinet:

- (1) accepted the Arts Council England grant offer of £881,487 a year over four years, and delegated authority to the Executive Director for Economy and Environment to finalise the terms and conditions of the grant agreement and execute the same and any associated or ancillary documents.
- (2) authorised the Executive Director for Economy and Environment to make arrangements for the future management of the New Art Gallery in conjunction with external advisors.
- (3) agreed to the appointment of V4 Services to continue with the procurement exercise, at a cost in the region of £20k and allocate funding for this, and
- (4) receive a further report once (2) and (3) above is complete.

## 3677 Whole settings approach to healthy eating in early years and schools

Further to this that under the Framework agreement, the provider trades for a further year from 1 September 2017 until 31 August 2021.
- (2) That Cabinet delegate authority to the Director of Public Health, in consultation with the Portfolio Holder for Health, to enter into a new contract to deliver a 'Whole Settings Approach to Healthy Eating in Early Years and Schools' by using the most appropriate procedures and to subsequently authorise the sealing or signing of any contracts, deeds or other related documents for such services.

## 3678 Aldridge Manor House

- (2) delegated authority to the Executive Director for Economy and Environment, in consultation with the portfolio holder for Regeneration, to enter into a development agreement with a developer and authorised the sealing of any contracts, deeds or related documents that may be deemed necessary for the proposed development of the Aldridge Manor House site and the acquisition of the land required for the development.
- (3)delegated authority to the Executive Director for Economy and Environment, in consultation with the portfolio holder for Regeneration, to enter into leases accordingly.
- (4) recommended the Council to approve a variation to the Capital Programme accordingly.
