3718 West Midlands Fire and Rescue Authority governance review

Councillor S. Coughlan presented the report:

In presenting the report, Councillor Coughlan advised that another Constituent Member, Coventry City Council, had made an amendment to the recommendation "to agree that the proposed arrangements for the West Midlands Fire Service should include the WMCA Fire Service budget being ring fenced for Fire Service functions."

Accordingly, Councillor Coughlan **moved** the recommendations as amended, which was duly seconded and:

Resolved

- (1) That Cabinet, as a Constituent Member of the West Midlands Combined Authority agrees the Governance Review (Appendix A) and Scheme (Appendix B) and that the proposed arrangements for West Midlands Fire Service should include the WMCA Fire Service budget being ring fenced for Fire Service functions.
- (2) That Cabinet agrees to move forward to public consultation for the Scheme and proposed governance model and support that consultation in Walsall.
- (3) That approval be given to delegate authority as required to the Chief Executive in consultation with the Leader to make minor amendments to the Governance review and Scheme on completion of the Local Authority approval process and prior to public consultation.

To recommend to Council

That the Governance Review (Appendix A) and Scheme (Appendix B) be approved.

3719 Call-in: Award of new contract for 0-19 early years locality services

The report of the Education and Children's Services Overview and Scrutiny Committee from its meeting on 6 November 2017, together with the report to Cabinet on 25 October 2017 was submitted:

Councillor Jeavons advised that he had agreed to allow one speaker from the public to address the Cabinet for a period of three minutes.

At this point, Councillor Jeavons read out the following legal advice to consider regarding the recommendation of the Overview and Scrutiny Committee:

"The Council has carried out a fair, transparent and legally compliant procurement process. In the absence of any breaches of the council's Financial and Procurement Rules as well as of the Public Contract Regulations 2015, the council must proceed to award the contract, subject to the 10 day standstill period. In the event of the Cabinet approving the contract proceeding further, the council is obliged to write to all the tenderers and explain to them why the council has awarded the contract to

a specific bidder. This triggers a 10 day standstill period during which parties affected can challenge the procurement process. Of course, Cabinet must satisfy itself that the referral from the Scrutiny Committee of 6 November 2017 has been fully considered in accordance with the process set out above".

Ms S. Shami addressed the Cabinet, representing users of Palfrey SureStart. She said that an online petition against the takeover of the centre by an outside company now contained over 1,500 signatures. Ms Shami shared a personal story and also shared the views of the users of the centre who wished the centre to be run by local people who she said understood the diverse needs of its community. She concluded by urging the Cabinet to keep the centre as part of the community.

Councillor Jeavons thanked the speaker for her representation. He then read out the following statement which he said evidenced full compliance with the principles contained within the Corporate Plan and Marmot principles:

and parents in the development and delivery of services

- Overview of how the organisation will support locality working

The bidders also had to evidence what partnerships they already had established in Walsall to deliver the service specification.
