	(a)		which goods or services are to be provided or are to be executed; and		
	(b)	which	has not been fully discharged.		
Land	Any beneficial interest in land which is within the area of the relevant authority.				
Licences	Any licence (alone or jointly with others) to occupy land in the area of the relevant authority for a month or longer.				
Corporate tenancies	Any tenancy where (to a member's knowledge):

		(ii)	if the share capital of that body is more than one class, the total nominal value of the shares of any one class in which the relevant person has a beneficial interest exceeds one hundredth of the total issued share capital of that class.
