## 607/13 Pension Schemes - Automatic Enrolment and Transitional Delay

A report was submitted:-

Lisa Hemus, Senior Manager, HR Direct Services and Andrew Pugh, Pensions Control Adviser, were in attendance and presented the report and highlighted the salient points contained therein.

In particular, Lisa confirmed that there would be no disadvantage to any Member of the pension scheme by approving the transitional delay. Implementing the transitional delay, however, would save the Authority a substantial amount of money and administrative work which would otherwise have to be funded from the Council's budget.

Lisa responded to some general questions from Councillor Towe in relation to the consequences of implementing the scheme and how Members would be affected.

Councillor Chambers then expressed his concern in relation to the short timescale involved as a decision was required by 1<sup>st</sup> March, 2013 and the Appointments Board had to make recommendation to Council at its meeting on 21<sup>st</sup> February, 2013. Furthermore, speaking in his capacity as a Member of the Audit Committee, Councillor Chambers stated that he would have liked to have been made aware of this during the consultation period.

Finally, Councillor Chambers wished to know what the Trade Unions had felt about this matter when it had been explained to them during the consultation process. Lisa acknowledged Councillor Chambers's points and explained that the report had been to Corporate Management Team and then subsequently the Employee Relations Forum before coming to Appointments Board.

Lisa went on to explain that the Unions at Employee Relations Forum were supportive of the implementation of the scheme as they had appreciated that no Members would be at a detriment. Furthermore, the Unions also acknowledged the financial and administrative impact such a scheme would place on the Council.

In closing, Lisa advised the Board that the Audit Team had been fully involved with this process and were currently reviewing it at present.

Councillor Chambers then asked if what was being proposed was fully in accordance with the law. Lisa replied that it was.

Following some more general questions on the report it was,

#### Resolved

That the Appointments Board recommends that Council approve the transitional delay of the Pensions Automatic Enrolment Scheme until 1<sup>st</sup> October, 2017 which will in turn avoid a potential financial strain of approximately £4.6 million per annum on the Authority.
