### **Apologies**

Apologies for non-attendance were submitted on behalf of Councillors Barker, J. Fitzpatrick, S. Fitzpatrick, and Turner; Father M. Leadbeater, Mrs V. Morris and Mrs R. Broughton-Mills.

The Chairman opened the meeting and announced that although the meeting was inquorate, the items not requiring a decision could be dealt with. Everyone present then introduced themselves at the meeting.

SACRE was informed of the resignation of Mrs P. M. Davis a representative of the Methodist faith.

### **Presentation by Faith Development Officer**

Mr.G. Nembhard, Faith Development Officer at Walsall Council gave a brief presentation on the work he was undertaking between the local authority and the multi-faith network in the borough. His role would be to strengthen the multi-faith network, liaising with strategic partners, promoting the interface multi-faith event and promoting cohesion.

Mr. Nembhard informed SACRE that he chaired the West Midlands Multi-Faith Forum and would be able to assist with promoting Walsall with the West Midlands Multi-Faith Forum. The West Midlands Multi-Faith Forum had a small board of members that dealt with business and a wider executive council which consisted of members from various forums and met on a quarterly basis. Meetings generally took place in Birmingham for ease of travelling as the membership included representatives from Coventry and Leamington.

The website for the forum was <a href="www.wmfaithsforum.org.uk">www.wmfaithsforum.org.uk</a>, and provided interesting information for members. He referred to work with organisations following the riots and efforts where being made to introduce faith into the heart of everything as faith had a valuable input.

SACRE thanked Mr. Nembhard for his presentation and wished him every success in his role.

### **Launch for Units of Work - Update**

Mr. Blaylock gave a brief presentation to SACRE and circulated a document outlining guidance and support for the teaching of RE for year groups 1 to 6:-.

The units were launched at the conference on the 5<sup>th</sup> July 2012 when approximately 30 attendees were present; the units were supplemented by a CD which would complement the units of work. The schools not represented at the conference would be given the opportunity to purchase the CD at a cost of £20.00. The disk was entitled "Broad Mind Deep Thoughts."

Mr. Richards confirmed that information relating to the conference would be posted on "The Well" and would be promoted through the subject leaders training session. The CDs would supplement the agreed syllabus.

Mr. Blaylock referred to the gifted and talented pupil conference which was held by Sandwell and Walsall SACREs and funded from a national trust that supported Religious Education; both authorities provided the administration and venue for the event. Year 8 pupils were pupil guides for Year 5 pupils and almost 100 children where involved in the day. Certificates where awarded to the Year 8 pupils for their work. Twenty-one teachers were in attendance. Consideration should be given to ways of self-funding an activity away-day.

Mr. Blaylock asked SACRE whether it should run this type of event for Walsall schools.

SACRE noted the outcome of the launch for the Units of Work and the gifted and talented pupil conference.

No monitoring of collective worship had taken place as schools had been reluctant to allow SACRE members into their schools. The use of the agreed syllabus had not been established as visits to school had ceased. Units of Work had been provided to support and supplement the syllabus and it was suggested that supporting collective worship could be included in subject leader and NQT training programmes.
