1789/08 Application to fell one protected ash tree at 18 Bell Road, Walsall

1794/08 Item No. 2 - 07/2661/RM/W7 – erection of 262 no. dwellings with associated works (reserved matters to outline application 07/0029/OL/W5) at former T.R.W. Automotive Systems Ltd, Woden Road West, Wednesbury

The Planning Officer advised the Committee of the background to the report.

The Committee then welcomed the first speaker Mr. Brownstone, who spoke against the application.

The Committee then welcomed the second speaker on this item Mr. Sambrookes, who spoke in support of the application.

The Committee then welcomed the third speaker Mr. Johnson, who also spoke in support of the application.

There then followed a period of questioning by Members in relation to noise pollution from existing industrial sites, bordering the application site.

A further question was submitted by Councillor Bott referring to resurfacing of a right of way from Woden Road. Officers reported that this would be included within the Section 106 arrangement.

Members considered the application and Councillor Bott **moved** and it was duly **seconded** by Councillor Micklewright:-

That planning application No. 07/2661/RM/W7 be approved subject to the conditions as contained in the report and supplementary paper now submitted and a planning obligation.

The motion having been put to the vote was declared **carried**, with seven Members voting in favour and none against.

1795/08 Item No. 5 - 08/0559/FL – redevelopment comprising four houses, vehicular access and landscaping at 71 Hall Lane, Pelsall, Walsall
