#### 3054 Long term empty dwellings use of compulsory purchase powers

Councillor A. Andrew presented the report:

#### Resolved

- (1) That the Executive Director for Resources be authorised to negotiate the voluntary acquisition of the properties listed in Table 1 of this report.
- (2) That in the event that the Executive Director is satisfied that voluntary acquisition cannot be achieved, authority be given to the making of a compulsory purchase order (CPO) under section 17 of the Housing Act 1985 in respect of those properties.
- (3) That the Executive Director for Resources be authorised to approve where appropriate agreements with owners of the properties setting out terms for withdrawing objections to the CPO;
- (4) That the Head of Legal Services be authorised to take all steps necessary for the drafting, making, submission and confirmation of the CPO and for vesting the properties in Council ownership and obtaining vacant possession where necessary.
- (5) That the Head of Legal Services be authorised, if granted power to do so by the Secretary of State, to confirm the CPO;
- (6) That the Head of Property Services be authorised to dispose of the properties with appropriate safeguards to ensure the properties are brought back into use

(7) That the full costs of the above recommendations (1), (2) and (3) be met in 2013/14 and 2014/15 from the approved New Homes Bonus Empty Homes allocation to the maximum allowable and that any proceeds from the disposals be 'recycled' into the New Homes Bonus account for Empty Homes work.

# 3055 Sale of former Three Crowns Special School

Councillor A. Andrew presented the report:

#### Resolved

- (1) That approval be given to the disposal of the freehold interest in the land shown edged in black on plan number EPMS 3878 Appendix A extending to 22,650 square metres (or thereabouts), provided:
  - (i) the terms agreed include the price satisfying the best consideration principles of Section 123 Local Government Act 1972; and
  - (ii) the purchaser bears the Council's surveyor's fees and legal costs.
- (2) That authority be delegated to the Executive Director for Regeneration in consultation with the portfolio holder for Regeneration and Transport to approve the terms for the disposal of the freehold interest in the site.

#### 3056 Meningitis case

At this point in the meeting, at the request of the Leader, the Director of Public Health, Dr. Gillis gave a short statement regarding the circumstances surrounding the death of a child from meningitis who attended a school in Bloxwich.

Dr. Gillis explained the steps taken to provide support to the family, to provide reassurances to parents of other children at the school, and to provide emotional support to those other children. Dr. Gillis requested the media to respect the privacy of the child's family at this sad time.

The Interim Director of Children's Services, Rose Collinson, gave her heartfelt sympathy to the family and friends. She also said that the Council would work closely with and provide support and reassurances to the school accordingly.

The Leader thanked Dr. Gillis and Rose Collinson for their response to this case.

# 3057 Rushall Primary School – Education Development Centre

Councillor A. Andrew presented the report:

#### Resolved

- (1) That approval be given to the allocation of £3m from the anticipated capital receipts identified from the disposal of the five former school sites detailed in this report, to be expended on the works identified for Rushall Primary School and associated additional accommodation.
- (2) That the Executive Director for Regeneration in consultation with the relevant portfolio holder be delegated authority to award contracts (including authorising execution/signature of the contract and ancillary documents) to the most suitable contractors having regard to Best Value for the works/services as set out and subject to a maximum budget of £3m.
- (3) That Cabinet approves the option to use an appropriate form of procurement and contracting arrangements determined by the Head of Property Services to provide the most efficient and value for money means of delivering the projects. This shall include consideration of traditional procurement and EU compliant framework contracts available to local authorities.
- (4) That Cabinet notes that the timing of expenditure will be in advance of receipt of income from the sale of the five sites and therefore there will be a cash flow implication for the Council, and approves that detailed design, procurement and construction can proceed prior to the capital receipts being obtained for the sale of the five sites.
- (5) That there will be no mainstream Council funding required over and above the allocation of the five schools sites and the scheme is delivered within the £3m set out.
- (6) That the revenue proposals to support the management and maintenance of the conference facilities to be provided as part of this project until the facility can become self financing be approved.

- (2) That approval be given to use of the Local Government Act 1972 General Disposal Consent (England) 2003 in order to dispose of the land for an undervalue of £20,000, the full market value of the site being in the region of £50,000.

# Summary of item considered in private session

# 3073 Walsall Business and sports hub

Further to a Cabinet decision on 24 July 2013 in respect of the disposal of land to Walsall College, the Cabinet received a report recommending amendments to the terms of disposal and decided to approve:

- (1) the substitution of the condition for the disposal of land on Littleton Street West to Walsall College, being conditional upon the letting of a construction contract by the date of the land transfer, with a buy-back clause, whereby if the College has not entered into a construction contract by the 1 October 2014, the Council is entitled to buy-back the land at the same market value with the College meeting the Council's stamp duty and professional fees.
- (2) the ring-fencing of the disposal proceeds until the date set by the buy-back clause for the entering into of a construction contract has been achieved.
- (3) that the requirement to achieve wider community use of the sports facilities was no longer considered to be necessary.
