The Chairman referred to the letter from the Private Hire Association and advised Members that the issues raised in the letter had been previously considered at the Taxi/Private Hire Liaison Group.

With regard to updating and revising the licensing paraphernalia displayed in private hire vehicles, it was **moved** by Councillor Robinson and duly **seconded**:-

That approval be given to the use of identification plates and side stickers supplied by VIP for both private hire and hackney carriage vehicles.

On being put to the vote, the motion was declared **carried** unanimously.

Resolved

That approval be given to the use of identification plates and side stickers supplied by VIP for both private hire and hackney carriage vehicles.

With regard to the unification of colour for private hire vehicles, Mr. Corlett suggested that there be no imposition of a single colour at this stage until the impact of the new identification plates was known.

Mr. Corlett advised Members that should the Committee agree to impose one uniform colour, this would involve conducting a survey of members of the public which would cost in the region of £20,000. There were no funds available in the budget which would necessitate a request to Cabinet to identify necessary funding.

It was subsequently **moved** by the Chairman and duly **seconded**:-

- (1) That the Committee impose one uniform colour for private hire vehicles phased in over five years, that colour to be silver;
- (2) That Cabinet be requested to identify the necessary funding to allow the public survey to be undertaken.

On being put to the vote, the motion was declared lost, five Members voting in favour and six against, with one abstention.

With regard to updating the licence plates for hackney carriages, it was,

Resolved

To require the display of additional information on the licence plate, the size of the licence plate fitted to a hackney carriage to be of sufficient size to accommodate the following information required:-

- (i) Plate Number;
- (ii) Registration Number;
- (iii) Expiry date of licence;
- (iv) Number of passengers licensed to be carried;
- (v) Licensing Authority identification.
