9. SACRE Constitution

Documents had been submitted.

Mr. Lat Blaylock from R.E. Today introduced himself and informed members of his substitution for Ms Fiona Moss. He advised members that Walsall SACRE's Constitution was due for review and he drew members' attention to the NASACRE Guidance document.

The document aimed to assist local authorities in reviewing the content of their SACRE Constitutions in accordance with the Education Act 1996.

In discussion with regard to the Constitution, members raised the following points:-

- Quorum to be reviewed (current attendance 8 members from 3 out of 4 groups)
- SACRE to consider including teachers on membership
- Vacant positions to be filled

Members to contact RE Today through the Clerk should they have any Constitution items for consideration.

Mr. Blaylock advised members of a request from Humanists UK to join Walsall's SACRE as either a full or a co-opted member. He further added that Humanists UK had approached all local authorities and that some SACREs had resolved to include a Humanist representative within their SACRE membership as a non-religious worldviews member. Following a detailed discussion about Humanism, members agreed to invite a Humanist representative to a future meeting to enable members to make an informed decision.

10. SACRE National Updates

RE Today/NATRE National updates had been submitted.

Mr. Blaylock advised members of the new Ofsted Framework. The Framework would increase the number of schools inspected by Ofsted with regard to RE teaching. It would ensure the teaching of RE met legal requirements and of a high enough quality. Ofsted Inspection reports were public documents and SACRE could request reports from the Local Authority when RE was highlighted.

Mr. Blaylock suggested a couple of actions for SACRE's consideration:-

- to offer support to schools ahead of their Ofsted inspections
- ii. SACRE be prepared with letters for schools following their Ofsted inspections to either congratulate or offer future RE support

In the discussion regarding Ofsted inspections, Mr. Orlik suggested the possibility of SACRE arranging training for schools with a potential to generate funding.
