2182 The future of Sneyd Community – A Specialist Maths and Computing College

Either outcome would be in keeping with the overall secondary educational strategy to establish vocational provision across the Borough and would fulfil the desire expressed by Walsall Council's Children and Young People's Scrutiny and Performance Panel to retain education provision on the Sneyd site
