1. Appointment of Chair for the 2021/22 Municipal Year

Mr D. Lomax was nominated and seconded.

2. Appointment of Vice Chair for the 2021/22 Municipal Year

Mrs P. Lane was nominated and seconded.

3. Welcome and Apologies

The Chair opened the meeting by welcoming everyone, and explaining the rules of procedure and legal context in which the meeting was being held. He also directed members of the public viewing the meeting to the papers, which could be found on the Council's Committee Management Information system (CMIS) webpage.

Members and officers confirmed that they could both see and hear the proceedings.

Apologies had been received on behalf of Councillor K. Hussain and Mr G. Tsiappourdhi.

4. Local Government (Access to Information) Act 1985 (as amended)

There were no items for consideration in the private session.

5. Minutes of the meeting held on 8 March 2021

The Chair put the recommendation to the vote by way of a roll call of members.

Resolved (unanimously by roll call):

That the Minutes of the meeting held on 8 March 2021 be approved and signed as a true record, subject to the inclusion of Dr G. Gomez's name in the list of attendees of the meeting.

6. Covid-19 and schools update

The RE Today Consultant, Ms F. Moss, provided a verbal update on the work being done with schools during the Covid-19 pandemic.

Ms Moss summarised the position for Walsall in terms of the impact being made by the Delta variant and the measures being taken, with it being noted that testing centres remained voluntary for school pupils and staff and that uptake of this was good and was being robustly encouraged. It was acknowledged that schools were currently operating under challenging conditions, and because of this, virtual networks of primary school teachers had been set up.

Further to a question on whether Ofsted inspections would occur during the next six months, it was noted that face-to-face inspections were to resume in September. Page 6 of 16

7. Collective worship

Presentations concerning the collective worship in their respective schools were made by Mrs H. Leadley, Blackwood School and St Anne's Primary Schools, and Mr A. Orlik, Blue Coat C of E Infant and Junior Schools' Federation:

- Collective worship: Pre- and post-lockdown. An overview from Blackwood School and Saint Anne's primary School, Streetly.
- Collective worship at Blue Coat C E Infant and Junior Schools' Federation

During discussion, appreciation was expressed in relation to both presentations.

Further to a question regarding the percentage of Walsall schools participating in collective worship, given that the national rate for secondary schools was 43 per cent, it was noted that participation for primary schools was a legal requirement.

8. New agreed syllabus

The new agreed syllabus: Religious Education Harmony and Diversity, 2021-2026 was submitted (see annexed).

The Chair introduced the item by thanking the members of the working group and Ms F. Moss and Mr L. Blaylock for their work in producing the new agreed syllabus, which it was proposed was to be implemented in community and voluntary controlled schools, as well as free schools and academies.

Ms Moss provided background information and summarised the production of the new agreed syllabus, which was a local responsibility for each SACRE and was undertaken every five years. It was noted that in reviewing the current agreed syllabus, a 'light-touch' review had been undertaken by the working group and that there had been liaison with teachers throughout the process. The presentation of the syllabus to this meeting was to seek SACRE's approval and for it to be considered by the Cabinet with a view to recommending the Council to approve its implementation in Walsall Schools.

A roll call was undertaken of all Members present, with each of the four respective groups (Local Authority, Lichfield Diocesan Board of Education, other faiths and religious denominations, and teacher associations) being fully represented.

Resolved (unanimously by roll call):

- 2. That the Cabinet be requested to recommend the Council to approve the new agreed syllabus: Religious Education Harmony and Diversity, 2021-2026 for implementation in Walsall schools.

9. New agreed syllabus launch and support

Ms Moss provided a verbal report on arrangements for the launch of the new agreed syllabus, which was planned for 2 November 2021. Whether this would be a physical event or carried out virtually was to be determined but both print and electronic versions of the syllabus would be available (the latter being uploaded to the Council website's SACRE page). Some units of work required 'refreshing' and enquiries to obtain funding for this were ongoing. The work to provide support to schools would continue, with network meetings being arranged on a regular basis.



National RE Updates for SACREs Autumn 2021

Research into public perception of an education in religion and worldviews

In summer 2021, Culham St Gabriel's Trust commissioned a survey to understand more about public perception of an education in religion and worldviews. The language used in the questions was chosen to try to avoid these misconceptions and to collect a more accurate set of data about what people thought about modern RE.

Some key findings:

Nearly two thirds (64%) of the UK adult population think that an education in religion and worldviews (or RE) is an important part of the school curriculum today, new research has revealed, with a further 65% agreeing that the subject has an impact on people's ability to understand each other in wider society.

Religious Studies: Public Examinations

Call for National Plan as Religious Studies GCSE entries

The number of pupils taking GCSE Religious Studies in England and Wales has fallen slightly in 2021, despite previously remaining stable since 2017. To safeguard the subject, the Religious Education Council of England and Wales and the National Association of Teachers of RE are calling for a National Plan, as recommended by the Commission on RE in 2018, to be funded by Government.

In England, RS GCSE entries for the full course fell by 2.4 percent to 221,419 compared with 226,767 in 2020. In Wales, entries rose by 3.6 percent from 9,997 in 2020 to 10,358 in 2021. Overall entries in England, including both full and short courses, fell by 3.4 percent to 237,091, compared with 245,544 in 2020. In Wales, combined entries fell by 5.4 percent from 15,436 in 2020 to 14,583 in 2021.

By comparison, GCSE entries to other humanities increased this year, with Geography entries up 4.1 percent to 274,715 and History up 0.8 percent to 286,706.

Hundreds more opt for Religious Studies at A-level in 2021

The number of Religious Studies A-level exam entries has increased 6.1 percent year on year. The subject outperformed other A-level subjects as a whole, which increased by 5.1 percent, with a greater increase than most other humanities subjects.
