Litter Issues

He also stated that the proposed access was within yards of a school and that the development would cause damage to Shire Oak Park.

Shire Oak Park

It was reported that groups of youths had been walking around Shire Oak Park with axes chopping down saplings. Mr. Corbett asked what plans were in place to prevent fires in Shire Oak Park. In response, it was suggested that the police be notified of any sittings of such anti-social behaviour. Also Parpinder Singh Randhawa would contact the Park Rangers to enquire if they would patrol the area more frequently.

Pavement opposite St. John's Church

Mr. Corbett stated that the pavement opposite St. John's Church had a considerable amount of litter on it. He also stated that the bins by the bus stop were a problem and that puddles were also an issue. Drainage channels in the pavement caused problems for wheelchairs.
