3694 Petitions

There were no petitions submitted.

3695 Question - Borneo Street allotment land

Mr. K. Mahmood asked the following question of Councillor Jones:

"The access to number 2 and number 4 Borneo Street was established and previously agreed by Walsall council. We have evidence showing this going back to 1974. The agreement with the allotments association was also in place, only the annual fee being the outstanding matter. In 2012 Cllr Adrian Andrew discussed the relocation of the allotments Gate in order to allow us access to the garage for number 2 and 4. This will allow us to use our garages without affecting the allotments. Taking this all into account we ask the Cabinet to consider granting access to the garages for number 2 and 4. We accept that the Secretary of State has come to a discussion not allow the proposed improvement scheme. However access can be granted outside of this scheme as it had in the past. We ask the council as landlords to allow access as previously established. You can use some of the money (£50,000) which was reserved for the proposed improvement scheme to relocate the entrance gate so we have access to the garage."

Councillor Jones replied as follows:

"Allotment legislation dictates that any loss of allotment land requires a Section 8 application to the Secretary of State. Walsall Council officers hold no record of any previous Section 8 request to Secretary of State for Borneo Street, therefore we can only work on the assumption that no previous formal permission for the access was sought from the Secretary of State.

Following the meeting with Councillor Adrian Andrew in 2012 to which you refer, officers were authorised to commence a Section 8 application to seek approval from the Secretary of State for works to the allotment site which would enable a shared access to be created. This was necessary as the sharing of access amounts to the loss of statutory allotment land.

The Secretary of State refused consent and the details of the application and outcome of the Secretary of State's decision are included on this Cabinet agenda."

3696 Changes to Borneo Street allotment land

Councillor Jones presented the report:

Councillor Nawaz, as Ward Councillor, said that he recognised that the decision of the Secretary of State to refuse consent to dispose of the land was disappointing for residents who had used the access in the past. He said that he understood the needs of residents in this respect and that it would have been good if an agreement could have been reached amicably between the residents and allotment holders however, the Council had followed due process and had referred this issue to the Secretary of State, therefore the matter had been taken as far as it could.

It was **moved** by Councillor Jones, duly seconded and:

Resolved

- (1) That Cabinet accepts the response from Secretary of State, which refuses consent to dispose of 280 sq. m. of statutory allotment land at the Borneo Street Allotments.
- (2) That Cabinet confirms that the scheme should not proceed.
- (3) That Cabinet approves £10,000 of capital funding to be spent on improvements at Borneo Street Allotments and for the rest of the capital budget to be reallocated to security works at the depot.
- (4) That Cabinet acknowledges the abortive costs.

Councillor S. Coughlan presented the report and thanked Cabinet members for their work to get to this point:

- (1) That the latest forecast 2017/18 financial position be noted.
- (2) That Cabinet note the financial assumptions and projections within the draft budget, the uncertainty around final funding, and that these assumptions may change as the budget progresses.
- (3) That the 2017/18 to 2020/21 provisional directorate revenue cash limits, saving and investment proposals be noted.
- (4) That Cabinet note that 2018/19 and 2019/20 are balanced, with further savings of c£10.7m in 2020/21 to be identified.
- (5) That the draft revenue proposals relating to the services within their remit be forwarded to each overview and scrutiny committee for feedback as appropriate, noting that overview and scrutiny committees have previously been consulted on all 2018/19 and 2019/20 policy saving proposals as part of the 2017/18 budget setting process and that feedback was taken into account at that point.
- (6) That proposals for 2018/19 to 2019/20 as set out in this report be referred for stakeholder consultation (where required), and for equality impact assessment, with feedback on these informing the final budget.
- (7) That Cabinet note that the medium term financial outlook position assumes an increase in council tax of 4.99% (including a 3% increase ring-fenced to adult social care) in 2018/19 and 1.99% for future years, the assumed level of "reasonableness" in respect of referendum principles, and that any changes to those principles, as set by the Secretary of State, may change the overall gap.

Should the final allocation be less than current estimates, revised proposals for ensuring a balanced budget will need to be brought back for Cabinet consideration as the budget develops and information is published.
- (9) That Cabinet note that the level of contingency funds and general reserves will need to be in line with the levels set out with the council's medium term financial strategy, the final level to be based on a detailed risk assessment which will be reported to Cabinet in February 2018.
