Feedback from the second meeting of the Strategic Advisory Group on 1st June 2016

1. Purpose

The Strategic Advisory Group (SAG) is a working group of Walsall Health and Wellbeing Board (HWB) that met, for the second time, on Wed 1st June 2016. The SAG has been set up to facilitate involvement with providers and partners around the key issues.

The topic for the meeting was the Sustainable Transformation Plan (STP). This paper provides feedback from the event.

2. Recommendations

2.1 That the members of the Health and Wellbeing Board note the feedback from the Strategic Advisory Group meeting shown in appendix 1

3. Report detail

The purpose of the Strategic Advisory Group (SAG) is to bring together a small group of key providers and partners to provide strategic input and support into the development and implementation of key programmes for which the Health and Wellbeing Board (HWB) is either responsible, or required to oversee.

The agenda items for meetings of the SAG are linked to the HWB agenda and work programme to enable outputs from SAG meetings to influence discussion and decision-making at the HWB. The topic of the meeting on 1st June was the **Sustainable Transformation Plan (STP)** and provided an opportunity to discuss the work undertaken, to date, on the development of the plan, both across the Black Country footprint and within Walsall.

Membership of the SAG and an indication of those that attended this meeting is attached **in appendix 1**. Members of the Health and Wellbeing Board were also invited to attend to learn more about the STP. In all, 22 people attended the meeting, listened to the presentations and got involved in the discussions. **Appendix 2** is a copy of the notes from the SAG meeting that will be sent out to all members.

The presentations and group discussions facilitated some interesting debate and various suggestions were made to clarify and enhance the plan. Members of the SAG were keen to remain part of the consultation process for the STP.

4. Implications for Joint Working arrangements:

As the SAG is intended to bring together a group of key providers and partners, joint working and co-operation is implicit in agreeing to attend and get involved in the discussions. Dependent on the identified topic for the meeting, HWB partners also co-operate to facilitate the presentations and event.

5. Health and Wellbeing Priorities:

The SAG is intended to facilitate discussion and input into identified issues and programmes related to the HWB. The Sustainable Transformation Plan covers all of the Marmot objectives to some degree, but in particular, the following:

- Create and develop healthy and sustainable places and communities
- Strengthen the role and impact of ill-health prevention.

Notes from Strategic Advisory Group (SAG) meeting held on 1st June 2016 at the Business Hub, Walsall College.

Present

It was agreed at the meeting that the contact list and sign in sheet used at the event would be circulated to participants. Those present at the event are shown.

Notes from meeting

Development of the Black Country Sustainability & Transformation Plan (STP):

Salma Ali, Accountable Officer for Walsall Clinical Commissioning Group, delivered the presentation - *slides attached to these notes*.

Development of the Healthy Walsall Partnership: - Walsall Together:

Paula Furnival, Exec Director of Social Care and Inclusion in Walsall, delivered the presentation - *slides attached to these notes*.

Following the presentations, the group feedback these points:

- The workforce should be sited as a key enabler in the programme. The cultural shift and skills development required will be key to the success of the programme.
- Some concern that mental health is not cited as one of the priorities. It was explained that mental health is integrated throughout the programme but its inclusion needs to be more explicit.

Paul Tulley, Interim Programme Director, Walsall Together, asked for feedback on specific elements of the programme as outlined in the presentation:

Vision: The phrase 'person at the centre' should be in the middle of the phrases rather than the end and also in the largest type. Generally people liked the vision in this format as modern and contemporary but recognised it would not be easily memorised as it was too long.

One comment was that it was a mixture of processes and outcomes statements. Could they be separated to state what will be delivered to the 'man on the street' as a result? It definitely needed to be made relevant to the general public.

Characteristics: Question – who were these characteristics aimed at, providers? Organisation? Professionals? The public?

Comment that the characteristics seemed relevant but could they be presented in a more accessible way?

Duplication occurred between the boxes. This needs to be prevented by greater clarification.

Safeguarding/safety were missing amongst the boxes. Safe services are very relevant.

Could holistic and person centred be joined?

Principles of Integration: Recognition that these applied more to organisations and professional than individuals.

What does this mean to the patient? Do we need to consult on a public facing document?

Question asked what would happen to this footprint and the Walsall place base if the combined authority went ahead?

Recognition that budgets needed to be integrated to enable facilitation and ownership.

Priority Projects: It was emphasised that the key enablers are the workforce.

Query about 'what does a healthy community look like?' Is it really covered by community resilience, isn't it also about what the community can do to help?

Concern that people with special needs or learning difficulties are not allowed to fall through the net.

Programme delivery: Walsall Together is linking with the STP and will be reliant on partners and other forums to ensure success. They will link into the Health and Wellbeing Board.

The SAG group stated that they would like to be informed of future developments in the STP plan and delivery.

Place based teams:

Donna Challoner delivered the presentation - slides attached to these notes.

Query why Mental Health professionals weren't currently members of the multi-disciplinary teams. Donna informed the group that MH professionals were already working very closely with the teams and were, in some instances, co-located.

Group talked about the meaning of 'place-based', how effectiveness can be evaluated and the risks/dis-benefits involved in this model of working.

Comment made that hospital admission avoidance doesn't necessarily reduce costs, it can just shift them to another area.
