Five Year Development Plan and Action Plan Update

Mr. Richard's referred to funding that had been made available for youth of SACRE to engage the services of RE today and sufficient funding was still available to cover 3 days work.

Mrs. Ensor informed the Sub-Group that when education returns to the local authority there would still be a requirement for funding to be made available for SACRE.

Annual Report

Mr. Richards circulated a copy of the draft annual report which covered the activities from January 2010 to 2012. The conclusion set out the issues with regard to engagement of schools.

Mr. Nembhard was of the view that the multi-faith forum could assist when the Serco contract ceased.

Mr. Richard's reminded the Sub-Group that the agreed syllabus would need to be agreed in 2015 and RE today had been training school staff in the contents of the agreed syllabus as well as units of work which feed into it. In respect of the courses provided and was being used to promote and train.

Self Evaluation

Mr. Richard's referred to the importance of SACRE carrying out a self evaluation and it would be necessary to establish whether information relating to the media, young people and how RE was dealt with at Walsall College.

Mr. Nembhard had provided the Chairman with a link from the multi-faith forum in respect of engagement of young people and consideration could be given to inviting young people to SACRE meetings.

It was agreed:-

- 2) That Mr. Blaylock carry out a training session in July.
