**CONFIRMATION OF TREE PRESERVATION ORDER 55 OF 2007 ON
LAND AT WELL PLACE, WALSALL, WS3 1LS.**

1. PURPOSE OF REPORT

To seek the confirmation of the Tree Preservation Order No 55 of 2007.

2. RECOMMENDATIONS

The Committee is recommended to:

- (i) Confirm the Walsall Tree Preservation Order No 36 of 2007 in a modified form. A plan showing the Tree Preservation Order is attached to this report.
- (ii) Support the reason for making the Tree Preservation Order set out in the report detail, paragraph 1.1.
- (iii) Note that no representations have been received in respect of this Tree Preservation Order.

3. FINANCIAL IMPLICATIONS

Within budget, in general, new Tree Preservation Orders generate additional applications for consent and increase officers' workload.

The owners and future owners of this site will be required to apply for Council permission if they wish to fell or prune any tree protected by the Tree Preservation Order. Failure to do this renders anyone carrying out unauthorised works to trees liable to criminal proceedings.

7. **ENVIRONMENTAL IMPACT**

The management of Walsall's tree cover through the administration of the Tree Preservation Order system has positive implications in protecting trees for their visual and environmental benefits. Removal of protected trees is often necessary because trees have a finite lifespan and may also cause nuisance or damage. In these instances the Council has to decide whether the removal of protected trees is justified. In the event that felling a tree is permitted, the Council can secure replacement planting to maintain tree cover.

CONFIRMATION OF TREE PRESERVATION ORDER 55 OF 2007 ON LAND AT WELL PLACE, WALSALL, WS3 1LS.

1.0 **REPORT DETAIL.**

- 1.1 The Tree Preservation Order No 55 of 2007 was made on 22 January 2007. The trees are visually prominent in the street scene and were protected for the following reasons:
- The trees form a prominent landscape feature in the local area and will continue to provide an important item of landscape quality in the future.
 - The trees add to the amenity and diversity of the immediate area.
 - The trees are at risk from proposed development and making an emergency Tree Preservation Order will discourage premature removal of these important trees.
 - The Council's Unitary Development Plan identifies policies for protection of the trees and green spaces.
- 1.2 The minimum six week period allowed for objection to the Order expired on 5 March 2007. No responses have been received.
- 1.3 Following a site meeting between the council and site developers it was agreed to omit the two Poplar trees at the eastern end of the site due to their poor form and relatively short useful life expectancy, replacement planting including size and species were discussed in mitigation for the loss of these two trees and have been included in the development proposals submitted to the council.
- 1.4 The Committee is therefore recommended to confirm Tree Preservation Order No 55 of 2007 in modified form.
