CONFIRMATION OF TREE PRESERVATION ORDER 7 OF 2004 AT 36 NEW ROAD, BROWNHILLS.

1. PURPOSE OF REPORT

To seek the confirmation of the Tree Preservation Order No 7 of 2004.

2. **RECOMMENDATIONS**

The Committee is recommended to:

- (i) Confirm the Walsall Tree Preservation Order No 7of 2004 in modified form. A plan showing the modified Tree Preservation Order is attached to this report.
- (ii) Support the reason for making the Tree Preservation Order set out in the accompanying report.
- (iii) Note that one representation has been received in respect of this Tree Preservation Order.

7. ENVIRONMENTAL IMPACT

The management of Walsall's tree cover through the administration of the Tree Preservation Order system has positive implications in protecting trees for their visual and environmental benefits. Removal of protected trees is often necessary because trees have a finite lifespan and may also cause nuisance or damage. In these instances the Council has to decide whether the removal of protected trees is justified. In the event that felling a tree is permitted, the Council can secure replacement planting to maintain tree cover.

CONFIRMATION OF TREE PRESERVATION ORDER 7 OF 2004 AT 36 NEW ROAD, BROWNHILLS

1.0 **REPORT DETAIL.**

- 1.1 Officers received calls from residents of New Road about approaches made to purchase land adjoining 36 New Road for housing development. The land at 36 New Road had recently been sold at auction. The rear of No.36 contains a good number of trees which are home to birds and other wildlife that the residents were concerned about losing. They also provide a screen between the proposed development and the houses of Vicarage Road.
- 1.11 Believing these trees to be under threat from construction, officers made an emergency Tree Preservation Order covering the entire area. Following a Tree Condition Survey by Rob Keyzor, an arborist working for First Post Homes, the order was amended on 03/03/05 to include only the trees considered worthy of preservation on health and condition grounds.
- 1.2 The Tree Preservation Order No 7 of 2004 was made on 19/10/2004. The reason given for the making of the Tree Preservation Order was as follows:
 - 'the trees included in the Tree Preservation Order are visually prominent specimens which contribute to the visual amenity of the neighbourhood and provide environmental benefits'.
- 1.3 The minimum six week period allowed for objection to the Order expired on 30/11/2004. One response has been received from Rob Keyzor, Tree Surgeon and Arboricultural Consultant, acting as agent for First Post Homes.
- 1.4 Mr. R Keyzor objects that the order is;

"poorly made and so all embracing as to include many trees that are not visually prominent, the visual benefits of which are mostly limited to the rear garden of the person who planted them and a limited number of people immediately adjacent."

At the time of making, this TPO was designed to cover the entire rear garden and all trees therein so as to quickly protect the trees and not alert the owners to the councils' intentions. Since then, the council has surveyed the trees and proposes to confirm a modified order containing just seven trees from the original order, all of which have considerable amenity benefits to the surrounding properties, especially in light of application 05/0460/OL/E5 for redevelopment of the property. Mr. Keyzors objection has therefore been, to some degree, addressed.

1.4 The Committee is therefore recommended to confirm Tree Preservation Order No. 7 of 2004 in modified form.
