Supplementary Paper Significant Changes to the Draft Plans

The recommendations to Cabinet include that the detailed form and content (not the substance) of the emerging documents and consultation material be delegated to the Executive Director for Economy and Environment. If there are any changes to the 'Draft Plan' documents, Policies Maps and / or the Preliminary Draft CIL Charging Schedule, which would go to the substance of the issues in question or the core of the policies such changes should be made in consultation with the Portfolio Holder for Economy, Infrastructure and Development.

However, three significant changes that should be drawn to the attention of Cabinet are listed below. The change to the wording of the proposed policy in respect of potential traveller sites is intended to clarify the status of the three "reserve" sites listed in the document. The change to the wording of the Green Belt policy is intended to address an emerging change in Government policy, whilst a reference to wildlife corridors has been added at the request of a statutory consultee.

Other changes may be made before the documents go to public consultation.
