Progress on review of the Agreed Syllabus

Mr. Taylor informed SACRE that Ms. Rosemary Rivett from RE Today had agreed to go through the draft of the document and to meet with Mr. Taylor on the 14 July for that purpose. The revised document would then be submitted to the Agreed Syllabus Working Group at its meeting in September prior to submission to the Agreed Syllabus Conference and SACRE.

Mr. Taylor recommended that SACRE should review the content of the Agreed Syllabus every year to ensure that the syllabus continues to be relevant, this would reduce the task when the next five year review became necessary.

Mrs. Blackmore suggested that 10% of schools be visited to look at the use of the Agreed Syllabus within those schools and use monitoring and feedback to update the Agreed Syllabus. Mr. Taylor confirmed that it was anticipated that the launch of the revised Agreed Syllabus would take place around Christmas and it was expected that schools would amend their planning of the curriculum from September 2010.
