05/15 REVIEW OF OVERVIEW AND SCRUTINY IN WALSALL

The Committee considered the findings and recommendations of a review of scrutiny undertaken by Professor Steve Leach. The report included details on the scrutiny committee structure and remits of committees (annexed).

The Chair reported on the new scrutiny structure appointed by Council following the Leach review. He was supportive of its findings and emphasised the importance of implementing its recommendations. He highlighted the very broad and strategic remit the committee had focussed on the Councils strategic priorities. Due to this broad remit the committee's business would have to be strongly managed. He supported the creation of working groups to consider issues in depth.

The Executive Director (Resources) highlighted further sections of the report focusing on changes to the way Members selected items and creating changes to the environment at committee meetings to create a different atmosphere more suitable to holding others to account. He noted that the report made a suggestion that scrutiny committees should receive more officer support and explained additional financial resources would be required if this part of the report was to be implemented.

Members of the committee were supportive of the report and its recommendations. In particular Members pushed the importance of training for new and old members alike as a key method of increasing knowledge that could be used to seek continuous improvement in the scrutiny process.
