### **EXCELLENCE PLAN**

Councillor Pitt asked how the Council classified homelessness.

Andrea Potts replied that the Council has no set definition but that central government defines the homeless as those who are without accommodation now, tomorrow and for the next 28 days. The Council has a duty to help those with priority needs, such as young families. However, she highlighted that the service was striving towards much earlier intervention and helping people stay in their current accommodation where possible.
