Feedback from Task Groups

A task group meeting was held on Monday 17th October 2005 to discuss potential hotspot areas which they would like Borough Resource Allocation Group (BRAG).

The Borough Resource Allocation Group is a management group of key partners and service providers, who meet monthly, to review and analyse current community safety data across the Borough. The group makes recommendations to the Safer Walsall Borough Partnership who task and coordinate resources in a multi agency response in order to improve hot spot neighbourhood issues and to meet the strategic objectives outlined in the strategy The task group highlighted 5 themes that they would like BRAG to pursue further. The identified themes were

Anti-social Behaviour Dog Fouling Traffic issues Litter issues Mini motorised scooters

BRAG will be in the Pelsall and Rushall LNP area from 30th January 2006 for 4 weeks.

Partnership Plan

At the last LNP meeting the LNP agreed to review the Partnership Plan. The first workshop was held on Thursday 1st December 2005 at Manor Farm Community Association. The task group were able to review the actions and progress of all the Environment, Health and Young People themes in the Partnership Plan.

The second workshop on Friday 9th December 2005 reviewed the actions and progress upon the elderly theme. The workshop came up with a number of projects that they would like to continue to develop.

The next workshop to continue with the review process will be held on Thursday 12th January 2006 at Rushall Community Centre, Springfields, Rushall. The workshop will aim to review the crime actions in the Partnership Plan and look at action planning for 2006-2007. As a result the LNP will be able to develop a clear set of actions and pledges for the next financial year that will demonstrate how they are making a difference and having an impact at a local level.'
