# 15/04 Presentation - Local Neighbourhood Partnerships

Councillor Aqeel Aslam gave a brief presentation to the Partnership and the members of the public present on Local Neighbourhood Partnerships. The meeting was advised that Walsall Council had launched nine Local Neighbourhood Partnerships (LNPs) in the Borough to work with local residents to discuss and make progress on key community issues.

Councillor Aslam advised that the nine LNP areas were based on Ward boundaries comprising:-

- Aldridge South and Streetly
- Blakenall and Bloxwich
- Brownhills and Aldridge North
- Darlaston
- Palfrey and Pleck
- Pelsall and Rushall
- Pheasey and Paddock
- St. Matthews and Birchills/Leamore
- Willenhall

Councillor Aslam said that Council officers would attend meetings of the Partnership to give advice, answer questions and take a record of the decisions made.

## 16/04 LNP meetings

The Partnership was advised that LNP meetings were open to the public and would meet in each LNP area every three months. It was confirmed that the details of dates, times and venues for meetings would be available on the Council's website and to members of the public by contacting their Ward Councillors for their area or the relevant Council officers.

### 17/04 Local Plan

The partnership was informed that one of the key issues for LNPs would be the production of a Local Plan for their area which would highlight local problems, key issues and priorities. The Local Plan would be based on a comprehensive set of background information and statistics and would enable LNP Members to make an informed series of decisions in respect of their area. Each LNP would manage and monitor its Local Plan, which would be consistent with the vision of Walsall Council and the Walsall Borough Strategic Partnership and that short term Task Groups could be established to take forward key issues in respect of each LNP Plan.

As part of the development of the Local Plan, it was confirmed that there would involve extensive consultation with local residents, businesses, service providers and voluntary community groups to ensure that all interested parties have an input into the preparation of the Plan.

Councillor Aslam said it was crucially important that members of the public were actively involved in the work of the LNP by participating in the preparation of the Local Plan and attending LNP meetings.

## 18/04 **Petitions**

Mr. Mark Pulford handed in a petition signed by the occupants of 102, 104, 106 and 108 New Mills Street, Palfrey with the request that the gate at the side of their four properties be replaced with a metal one as a number of properties in the area had been burgled.

Mr. Kasujee, of 127 Lord Street, informed the Partnership that he did not consider that many people knew the various improvement projects which were taking place in the Palfrey and Pleck areas and said it was important that these were drawn to public attention.

Mrs. S.J. Spencer, of 47-49 Dale Street, advised the Partnership that in her opinion, the selection process for Locally Appointed Partners had been very badly organised and handled and that people had not been kept advised of the process.

Mr. Muhammed Lulu Miah, of 182 Milton Street, said that he was very interested in supporting the work of the Local Neighbourhood Partnership and wished it success in the future.
