1. Summary of report

This report presents the final comments and recommendations of all 5 scrutiny and performance panels following consideration of the draft corporate budget report at meetings held in January 2009. This will enable consideration by Cabinet before they make their final budget recommendations to Council.

2. Recommendations

To note the recommendations of all five scrutiny and performance panels as detailed in the **appendix 1** and consider them when making final budget recommendations to Council.

3. Background information

Scrutiny has received information to consider throughout the budget process. This includes resource planning documents for the services within their remit in the autumn and the draft budget proposals in January. Corporate scrutiny has also received resource planning documents for all services across the council. This report contains the recommendations from each panel from their January meetings to enable Cabinet to consider them prior to recommending a final budget to Council.

4. Resource considerations

Financial: The consideration of the draft budget reports by the scrutiny panels is an integral part of the council's budget setting process. **Appendix 1** summarises feedback from the Health Social Care and Inclusion and Regeneration Scrutiny and Performance Panels held on 19 January 2008, the Children's and Young People Scrutiny and Performance Panel held on the 20 January 2009, the Neighbourhood Scrutiny and Performance Panel held on 22 January and Corporate Scrutiny and Performance Panel on 23 January.

5. Citizen impact

The budget is aligned with service activity within service plans across the council. Investment has been targeted at service improvement, stability and user demand.

7. Environmental impact

Budget decisions may affect the council's ability to deal with environmental issues.

8. Performance and risk management issues

- 8.1 **Risk**: The council annually reviews corporate financial planning and budget principles. In November cabinet approved an updated Medium Term Financial Strategy (MTFS). The budget setting process includes a corporate financial risk assessment to determine key risks and their impact on the budget.

• The Health, Social Care and Inclusion Scrutiny and Performance Panel met on 19 January 2009, considered each item in their remit but made no specific recommendations with regard to the draft budget proposals for 2009/10 – 2011/12.

Recommendations of the Regeneration Scrutiny and Performance Panel

- That consideration be given to a voluntary reduced hours proposal or job share between existing employees to avoid the deletion of two principal planning officers as proposed in saving 116;
- That consideration be given to voluntary reduced hours, job share or retraining schemes for all posts at risk of deletion or redundancy across the Council to retain skills within the workforce

Recommendations of the Children and Young People Scrutiny and Performance Panel

- The withdrawal of funding for Ready Steady Summer scheme to be referred to the Neighbourhoods Scrutiny and Performance Panel
- The draft children's services revenue and capital budget proposals for 2009/10 to 2011/12 be supported

Recommendations of the Neighbourhood Services Scrutiny and Performance Panel

- Cabinet reconsider efficiency/saving proposal 44 'NPP stop funding the LNP community cash scheme' as this is a valuable resource to local neighbourhood partnerships to help deliver local projects and programme across the borough;
- Alternative ways for customers to pay car parking charges, including accepting bank notes, debit cards and other electronic methods, be investigated;
- As part of any planned replacement of car park ticket machines consideration should be given to introducing ticket machines that print car registration numbers on tickets to the transfer of tickets between vehicles;
- The Panel consider the Councils use of Bryntysilio and potential alternatives during 2009/10;
- The summer youth activities be actively promoted throughout the borough within existing resources.
