3350 Walsall Local Plan

Councillor Andrew presented the report, together with a supplementary report:

Councillor Andrew commented that he considered this to be an exceptional report and thanked the Regeneration Manager, Mike Smith and his team for their hard work on this project. He stressed the importance of the local plan and urged everyone to take part on the consultation.

Resolved

- (1) That Cabinet agrees to publish material for consultation on three Walsall Local Plan documents:
 - (a) Walsall Site Allocations Document Preferred Options
 - (b) Walsall Town Centre Area Action Plan Preferred Options
 - (c) Preliminary Draft Community Infrastructure Levy Charging Schedule
- (2) That Cabinet agrees that consultations should begin at the start of September 2015 and should run for 8 weeks.
- (3) That the detailed form and content (not the substance) of the emerging documents and consultation material be delegated to the Executive Director for Economy and Environment. If there are any changes to the 'Draft Plan' documents, Policies Maps and / or the Preliminary Draft CIL Charging Schedule, which would go to the substance of the issues in question or the core of the policies such changes should be made in consultation with the Portfolio Holder for Economy, Infrastructure and Development.
- (4) That Cabinet agrees that this consultation should be publicised in advance of the September start, and that all members of the Council and all Council services concerned with the use of land and premises should be asked to participate positively in the consultation and encourage members of the community and relevant interest groups to do so.
- (5) That Cabinet agrees to receive reports to future meetings and notes there will also be reports to Council in accordance with the process for the preparation of the documents set out in paragraph 3.5 of this report.

Resolved

- (1) That the Cabinet approves the Walsall Adult and Community College Operational Plan and Budget for 2015/16.
- (2) That the Cabinet approve that delegated authority be given to the Executive Director of Resources, or their authorised representative, in consultation with the Leader of the Council, to:
 - (i) Act as the Council's representative for the purposes of when the Council needs to take any steps or action in its capacity as the sole member of the new charitable company:
 - (ii) Act as Walsall Council's representative at all Directors meetings of the new charitable company (including any general meeting);
 - (iii) Approve the appointments of the Chairperson and Vice-Chairperson of the new charitable company, on behalf of Cabinet;
 - (iv) Approve the final form of the Commercial Transfer Agreement, once this has been negotiated between Walsall Adult and Community College's solicitors and officers on behalf of the Council, so that this can be completed immediately prior to the initial spin-out of Walsall Adult and Community College on 1 August 2015:

- (v) Oversee and performance manage the operation of the new Walsall Adult and Community College charitable company, in order to ensure that while it remains wholly owned by the Council, the new company complies with its Articles of Association, statutory obligations and the Council's requirements in general;
- (vi) Oversee, manage and drive the spin-out of Walsall Adult and Community College to the point that it is able to become completely independent from the Council within a target period of two years from 1 August 2015.
- (vii) To sign or execute any deeds or documents on behalf of the Council pursuant to the spin-out of Walsall Adult and Community College.

3353 Award of contracts for public health falls prevention services

3354 Transition of health visiting services from NHS England

Councillor Martin presented the report:

Members were concerned that the service would be transferred with insufficient funding and asked for a letter expressing members concerns to be sent to NHS England.

Resolved

- (1) That Cabinet note this report detailing the statutory transfer of the commissioning responsibilities for public health services for 0 to 5 year olds from 1 October 2015 from NHS England to Walsall Council.
- (2) That Cabinet awards an interim transitional contract for public health services for children aged 0 to 5 to Walsall Healthcare NHS Trust from 1 October 2015 to 31 March 2017 under Regulation 32 of the Public Contracts Regulations 2015 (use of negotiated procedure without prior publication) in order to allow a sufficient and reasonable period of time to develop strategically aligned public health services for children aged 0 to 5.

- (3) That Cabinet delegate authority to the Director of Public Health in conjunction with the portfolio holder to enter into the 18 month interim transitional contract as detailed in 2.2 with Walsall Healthcare NHS Trust to deliver the public health services for children aged 0 to 5, by using the most appropriate procedures (publication of Voluntary Ex Ante Transparency notice) and to subsequently authorise the sealing or signing of any deeds, contracts or other related documents to enter into agreements for the provision of such services.
- (4) That Cabinet delegate authority to the Director of Public Health to consider the integration of the current infant feeding service contract currently provided by Walsall Healthcare NHS Trust with the Healthy Child Programme 0-5 from 1 April 2017.
- (5) That Cabinet note this report detailing the action plan to develop and procure an integrated public health service for 0-5 year olds by 1 April 2017, as detailed in paragraph 3.10 of this report.

3355 Youth service – outcome of consultation

Award of contract for public health falls prevention services

Councillor Martin presented the report:

Resolved

- (1) That approval be given to the award of the contracts for Walsall Falls
 Prevention Services for a period of three years, to commence service
 delivery from 1 November 2015 until 31 October 2018, with an option to
 extend the initial term of such contracts by up to two years for:
 - (a) Lot 1 concerning the Population Falls Prevention Service to be awarded to Bid Number 1, who submitted the most economically advantageous tender based on the quality of their submission and the price offered with a total tendered cost of £129,367 over the initial three year contract period; and
 - (b) Lot 2 concerning the Community and Specialist Falls Prevention Service to be awarded to Bid Number 5, who submitted the only tender based on a total tendered cost of £953,998 over the initial three year contract period.

(2) That authority be delegated to the Director of Public Health in consultation with the Portfolio Holder for Public Health and Wellbeing to enter into new contracts to deliver Walsall Falls Prevention Services by using the most appropriate procedures and to subsequently authorise the sealing of any deeds, contracts or other related documents for such services.
