He was concerned that this should be delegated to an Officer and not the Committee. The Legal representative (Mr. Patouchas) explained that as the Act had not been listed in the Schedules to the Local Authority (Functions and Responsibilities) (England) Regulations, 2000 it was an "executive function" and as such was dealt with by Officers.

Councillor Fitzpatrick asked if the Police were taking action against unlicensed scrap metal collectors. Mr. Knapper replied that Officers and the Police had carried out successful scrap metal days in December, 2013 and February 2014.
