Local Area Agreement Quarter 3 Monitoring Report

Report:

This briefing note informs the Panel of progress against the performance of Local Area Agreement (LAA) targets for the period of Quarter 3 2009/10. On the basis of the information within this note the Panel may consider additions to its work programme.

Appendix 1 sets out performance of those indicators relevant to the Environment Scrutiny Panel, with Appendix 2 listing the remaining indicators within the LAA. Within the table Red, Amber and Green ratings have been attributed to each indicator based on the latest position against 2009/10 targets, with additional comments providing background to these ratings.

The current position shows there are two Green, one Grey (where recent outturn data is currently unavailable) and two Red rated Indicators (National Indicator 186 - Per Capita % reductions in CO2 emissions in the Local Authority area and NI198 - Children travelling to school) of relevance to this Panel.

Explanations on the current position of the Red rated targets have been provided below.

Members are requested to note that the 'Per Capita % reductions in CO2 emissions' target is measured against the three following sectors; Domestic Housing, Business and Road Traffic - based on data available from the 'National Hub'. Previously this indicator has reported an increase in the tonnage of CO2 emissions in the local area from 2004/05 to 2005/06 (7.18 to 7.4). Due to the data attributed to this indicator being heavily delayed it is almost impossible to link the activity undertaken against the agreed LAA target. As a consequence the Climate Change Executive group have proposed a new measure to simply reduce 75 tonnes of CO2 in the borough through energy efficiency projects and initiatives. Whilst work is being undertaken in establishing a new monitoring mechanism for this new measure, it has been agreed to continue rating NI186 as Red, reflecting the nationally out-turned picture.

Through the Corrective Action Plan, the lead officer for 'Children travelling to

School' has stated that detailed analysis of the data highlights that the increase in car usage can be attributed mainly to those pupils in secondary education. It is believed the development of academies may be contributing towards this, with pupils being required to travel further to attend their chosen school. Additionally the schools closure programme is also considered to be a contributing factor in the failure to meet the target with pupils facing longer journeys to attend school. Whilst the 2009/10 data has been rated as Red it does not mean that we will not achieve the LAA target which will be informed by results from both the 2010 and 2011 school censuses.

Recommendations:

That:

- 1. Members note the current position on those indicators relevant to the panel.
- 2. Members consider including the achievement of failing targets in their work programme.

So as our improvement strategies progress their success will be reflected in an improved out-turn. Whilst this indicator continues to rag RED; we are optimistic for improved outcomes.
