Mrs. Ensor reminded the Sub-Group of the discussion that took place at SACRE on 13<sup>th</sup> June, 2011 on training for public sector staff joining Walsall.

Councillor Robertson confirmed that WHG were keen to be part of a scheme of this nature and there was a commitment on their part to move this forward. He referred to a number of invitations he had received from various faith groups and felt that these should be encouraged. There had been an indication that various groups were keen to break down barriers, there could also be funding to be gained from some groups. Interest had been expressed in particular by the Muslim communities.

Councillor Robertson suggested that invitations to events could be made via the Internet, the Governor network could also be used. It was agreed that a report be circulated to the September meeting.

Councillor Robertson suggested that children's art could be displayed in the Museum. He referred to the possibility of art exchange and twinning. Ms. Saggu undertook to investigate this matter further.
