**Purpose of the report:** To follow up on the request from Schools Forum in July 2014 for further information about the admissions service and the budget gap.

## 1. Background

- 1.1 In July 2014 Schools Forum received a report stating that an increase in DSG funding was required to maintain the level of funding in admissions.
- 1.2 Following the report the resolution was, "*That officers submit a report to WASH and Primary Forum setting out the statutory requirements and costings as well as the additional requirements and costings of the Schools Admissions Service and that their comments be submitted to Schools Forum.*"
- 1.3 A copy of the report that was submitted is attached as **Appendix 1**.
- 1.4 Further work has gone on to review the cost of the admissions service and a revised budget plan for 2015/16 is submitted.

## 2. Regulations

- 2.1 Schools Admissions service is funded through Dedicated Schools Grant (DSG). The Schools and Early Years Finance (England) Regulations state:

*CLASSES OR DESCRIPTIONS OF PLANNED EXPENDITURE  
PRESCRIBED FOR THE PURPOSES OF THE SCHOOLS BUDGET OF A LOCAL  
AUTHORITY WHICH MAY BE DEDUCTED FROM IT TO DETERMINE THE  
INDIVIDUAL SCHOOLS BUDGET*

*1. Expenditure on the operation of the system of admissions of pupils to schools (including expenditure incurred in carrying out consultations under section 88C(2) of the 1998 Act(a)) and in relation to appeals.*

*5. Any deductions under any of paragraphs 1, 2, 3, 4(a), 4(b), 4(c), 4(d) and 4(e) must not exceed the amount deducted under each of the corresponding paragraphs of Part 1 of Schedule 2 to the 2012 Regulations for the previous funding period.*

- 2.2 In simple terms this means that all costs for schools admissions should be charged to DSG but the total costs should be no more than the previous year budget.
- 2.3 This report explains why that position is not sustainable in Walsall and looks for a Schools Forum decision to advise on the future.

## 3. Schools Admissions Costs background

- 3.1 The schools admission service in Walsall was previously part of the outsourced education contract. In the final year of the Serco contract the cost of the Schools Admission service was established as **£240,839**.
- 3.2 The problem with using this information is that the Serco contract was a fixed price contract. In essence, the price paid was not necessarily the cost of the service. Since 1 April 2013 when the contract terminated and all remaining services returned to Walsall Council, it has become clear that the cost of school admissions is greater than £240,839.
- 3.3 Based on the regulations stated in Section 1 above, there is no way to use extra DSG to fund the admissions service. This clearly creates an issue.

3.4 Advice was sought from the Education Funding Agency about the options that are available. The advice from the EFA can be paraphrased as:

3.4.1 Reduce the service to fit within the funding envelope

3.4.2 Pay for the costs above the DSG contribution with other Council monies

3.4.3 A request can be made to disapply the regulations and increase the budget. A robust case would need to be made. This would need to explain why it is not possible to make the efficiencies within central budgets which would be expected from a flat cash settlement and which are being made within non-schools budget. Evidence would need to be provided of the full support from the Schools Forum, including from academies members

3.5 The remainder of this paper deals with these options and principally disapplying the regulations

#### 4. Current Costs of the Service

4.1 The total cost of the Schools Admissions service is estimated to be **£362,727** for 2014/15. However this decreases to **£330,543** in 2015/16 **Table 1** gives details of costs:

4.2 The difference between running the costs of the service and the funding from DSG is **£89,704**.

4.3 It must be noted that the analysis of the costs shown above is based on the budget for one year. Clearly there may be other costs which will occur less than once per annum e.g. software costs.

## 5. Benchmarking

5.1 The July 2014 report included benchmarking data. This data has been re-produced in **Table 1**, **Table 2** and **Appendix 1**. It has been updated for the revision in 2015/16 projections for Walsall. There has been a desktop exercise looking at West Midlands data (per capita to zero decimal places) and it is broadly the same for 2014/15.

5.2 The information in the benchmarking is the 2013/14 budget for school admissions from the Section 251 statement.

5.3 Section 251 information is the best source of information available. However, it must be noted that some anomalies in the data will raise concerns about the data being 100% accurate. Therefore this benchmarking must be taken as a guide rather than an absolute.

5.4 **Table 1** shows the information of a 'wider West Midlands' section of local authorities ranked by cost per pupil of school admissions. This is cost of the service as appearing on 1.4.2 School Admissions divided by number of pupils 3-19 in maintained and recoupment academy schools. (This is the definition DfE use). Walsall is included as it is now and as it would be based on actual cost.

5.5 **Table 2** is the same data but ranked by total net cost of the service and no reflection on size of authority.

5.6 **Appendix 1** is the same data ranked by pupil for all local authorities in the country.

## 6. Commentary

6.1 Whichever measure is used, it is clear from **tables 1 and 2** that the funding allocated to Walsall is one of the lowest, if not the lowest in the wider West Midlands. The average per pupil across this group would be **£8.35** (based on current Walsall only).

6.2 The data will have limitations as Coventry has c50% more pupils than Solihull but has nearly 200% more cost. In **appendix 1** one LA reports zero cost and there are other statistical outliers. There is a concern that some of the variation is caused by difference in reporting approaches rather than actual cost. However, excluding this data, Walsall will remain a lower funded admissions service.

## 7. Further Governance

7.1 To be absolutely clear, any increase in costs that Schools Forum are content to support can **only** be spent on schools admissions **actual** costs. Any underspend on this budget would revert to schools. These monies cannot be spent on any other activities.

7.2 Even if Schools Forum support an increase, further approval would be needed from the EFA.

7.3 While the EFA have not been explicit in their response, it is clear that they would see that disapplying the regulations would be an exceptional step. It is unlikely that a disapplication could be sought again / every year.

7.4 For the 2014/15 budget there is believed to be sufficient surplus to cover an increase in this budget. Further analysis and budget planning would be required for 2015/16 which Schools forum will be involved in.

7.5 Any increase in funding would have a net effect and reduce the overall surplus.

## **8. Recommendations**

8.1 Schools Forum recognise that the current cost of the admissions service is more than the Dedicated Schools Grant funded provided.

8.2 Schools Forum recommend one of the following courses of action:

8.2.1 Schools Forum refuses to recommend an increase in funding from DSG for admissions. It recognises that Walsall council will therefore have to reduce the expenditure, and probably the current service, due to budget constraints.

8.2.2 Schools Forum recommends to the EFA an increase in funding from DSG for financial years 2015/16 and 2016/17 of c£90,000 to £331,000 per annum. This increase will be used to run the service in the short term and allow officers and schools to work together to develop the best service for children, parents and families.
