Members were informed that the meeting was at present inquorate and it was agreed that the presentation by Mr. Sacha on Islam be heard at this point.

Mr. Sacha put on a display of religious books and artefacts; he recited the some words from the Quran, the words were used in the five daily prayers and were spoken in Arabic. Pictures showing the holy city of Madinah, the Dome of Rock in Jerusalem, the holy city of Makkah and the door was the entrance door to the holy Kahbah.

Mr. Sacha referred to the Muslim way of greeting people in Islam. The Quran was written in Arabic, but there were translations in English.

The word "Islam" meant submission and derived from the word meaning "peace" and in a religious context it meant complete submission to the will of god. Half of the faith related to cleanliness and all other things around us in life; it was our duty to look after neighbours, regardless of their religion and being honest was crucial in this.

The six articles of faith were:

- (1) Belief in Allah
- (2) Belief in angels
- (3) Belief in the books (scriptures) of Allah
- (4) Belief in the prophets of Allah
- (5) Belief in the day of judgement
- (6) Belief in the divine laws

The five pillars of Islam were the five main duties a Muslim had to perform:

- (1) Shahadah the belief in Allah and the messengers of Allah
- (2) Alaah daily prayers

- (3) Paying of Zakh
- (4) Fasting in Ramadhan
- (5) Performing the pilgrimage to Makkah

The five obligatory prayers were:

- (1) Fajr early morning prayer, begins at dawn and ends just before sunrise
- (2) Zuhr midday, between 1.00 p.m. to 1.30 p.m.
- (3) Asr mid-afternoon 7.00 p.m.
- (4) Maghrib immediately after sunset
- (5) Isha approximately 11.00 p.m.

During Ramadhan, fasting took place from sunrise to sunset and children from the age of 10 were encouraged to take part in fasting, although from maturity it becomes an obligation. The fast was broken with dates and water and the family communication get together in the mosque. Ramadhan was the month of cleanliness and during that period, in particular, extra thought was given to the poor and the needy. Zakah means to purify oneself and 2.5% of a persons total wealth was given to charity for the needy. During Ramadhan, people visit mosques more often and are reminded to cleanse their bodies and minds, to give to charity and the needy, heart, body and mind would be surrendered to the faith and the fast must end at a particular given moment in the day and you must eat. Any person exempt from fasting, for example, through illness or pregnancy, they would have to pay approximately £3 to the charity.

Hajj, this is the house of god in Makkah in the holy city of Madinah and anyone who is wealthy enough to visit, it is their obligation to do so once in their lifetime, although those who could not make the trip through illness or financial reasons would not be committing a sin. The people that have made the trip are known as Hajj's, this year approximately 5 million people attended and the event was hosted by Saudi Arabian Government who were the custodians of the two mosques and all the health and safety aspects are built into the area.

The Imam would lead the congregation.

In Jerusalem Al-Aqsa was the third most sacred place on the world and was the third holy shrine. Although it was not obligation to visit Al-Aqsa, it was a requirement and Muslims were recommended that they visit the Dome of Rock in their lifetime.

SACRE thanked Mr. Sacha for the informative presentation.

In response to points raised by members, Mr. Sacha introduced Mr. Aslam who had lived in Walsall for 46 years, he worked for charities and been involved in the Health Service and was recently awarded the MBE.

At this juncture, the meeting became guorate.
