1/13 Apologies

Apologies for non-attendance were submitted on behalf of Councillors Clarke, Harris, Hughes and Murray.

2/13 Declarations of Interest

4/13 Funding Procedures

The report of the Partnership Manager was submitted:-

The Area Manager (John Morris) enlarged upon the report and informed the meeting that the major change was that Area Panels would make the decision on grants rather than Area Managers. He added that authority was sought for Area Managers to approve urgent projects up to a value of £500 in consultation with the Chairman, Vice-Chairman and relevant Ward Members.

Members expressed disappointment that Area Managers could no longer approve grants. They felt that the previous system had worked well. Concern was expressed that applications which came in late could create a problem and that the gap between meetings was too long.

Councillor Towe expressed concern that the new procedure would create a problem ensuring funding was available when needed. He felt that the process needed to be reviewed urgently.

John Morris informed the meeting how the funding process would work.

After further discussion it was,

Resolved

That the Area Panel:-

- (1) notes that they have authority to make decisions on Area Partnership funding where allocated to an Area Partnership area by the Council;
- (2) approves delegated authority to the relevant Area Manager for any urgent projects, up to the value of £500, in consultation with the Chairman, Vice-Chairman and relevant Ward Members.

5/13 Funding Report

The Area Manager (John Morris) enlarged upon the report and indicated that two projects had been carried forward from 2012/13. He then drew attention to the projects approved prior to the changes approved by Council on 22nd May, 2013. He added that there remained £27,269.84 for the Area Panel to disperse on project applications.

8/13 **Devolution through Area Partnerships - Update**

The Communities and Partnerships Manager (John Leach) enlarged upon the report and drew attention to the salient points contained therein. Members asked about participatory budgeting and John Leach drew attention to the two service specific pilots - Clean and Green, focussing on street cleansing and grounds maintenance and highways maintenance, focussing on road safety, parking and maintenance.

Councillor Douglas-Maul referred to grass cutting and to the complaints regarding grass clippings not being collected. It was reported that a policy decision in 1992 had led to gang mowers only being used. John Leach indicated that the community could decide on the frequency of the grass cutting cycle under this initiative.

Members asked how participatory budgeting would be publicised. John Leach replied that a range of mechanisms would be used, including the website, Area Manager connections, partnership connections and social media.

Councillor Towe referred to the support for attracting funding and asked if the Strategic Resource Officer (Alex Boys) could attend the next meeting of the Panel to explain his role.

John Morris reported that Alex Boys would be attending the Streetly Networking meeting on 10th July, 2013.
