**RE: Commissioning NHS Dental Services on the East of the Borough of Walsall**

## Purpose

To provide Members the opportunity to comment on the proposed procurement of dental services by NHS Walsall as part of its Oral Health Improvement and Dental Commissioning Strategy.

## Background

Currently the East of the Borough has only one dental practice accepting new NHS patients compared to 14 dental practices in the West accepting new NHS patients. There are significant issues with people finding an NHS dentist in the area and the provision of additional services will provide equitable access that is local and convenient.

Our priorities are to deliver better oral health by:

- investing in oral health promotion and disease prevention to reduce inequalities in dental health; enabling people to maintain good oral health for as long as possible
- increasing the provision of NHS dental services close to where people live
- commissioning evidence based high quality dental services that are accessible to all that need them.

The Government's vision for the future of dental services was set out in Options for Change, June 2002. It heralded reform and envisaged dentistry being an integral part of the wider primary care network. Access to NHS dentistry is a national priority and the Department of Health have made available funding for PCTs to increase access in their areas.

A copy of the public consultation document is attached for information. The document sets out the tPCT's plans for the east of the borough for comment. Please note that although the formal consultation process ended on 19 February 2009 the Panel's comments will be reported to the tPCT Board meeting that considers the outcome of the consultation.

Under the Health and Social Care Act 2003, the budget and commissioning for NHS dentistry was devolved to local PCTs and from 1<sup>st</sup> April 2006 Walsall Teaching Primary Care Trust (NHS Walsall) became responsible for NHS dentistry in the local Walsall area, including responsibility for dental public health and urgent and out of hours care.

## About this consultation

This is a formal consultation by NHS Walsall about the best place for new dental practices in the East of Walsall. As it is a formal consultation, you have 12 weeks to respond, from 27 November 2008. All responses will be taken seriously, and we are happy to take responses on paper, by email, through the internet, by phone, in person, or in any other way that suits you. We can also provide this document in a different format or language on request. You can respond as an individual or as an organisation. We expect most responses will come from people who live or work in Walsall, but anyone with an interest in this issue is welcome to respond.

## Summary of the proposal


Access to NHS dentistry in Walsall is difficult in some parts of Walsall. In the East there are significant issues with equitable access particularly in **Pheasey Park Farm** and **Streetly** Wards, which also have the lowest percentage of residents accessing an NHS Dentist (between 10 and 21%).

To improve access to dental care in these areas NHS Walsall is planning to procure one new large practice or two small practices in the East via a competitive tendering process.

Our intention is that the new practice or practices will treat at least **5,000 patients** every year and cost around half a million pounds.

This will provide the opportunity for new patients to access NHS dentistry locally and conveniently and to address inequality of access in the East.
