Mr. Flynn outlined the content of the report and in particular the production of the Units of Work which now totalled 18; the Local Authority was now more efficient at sharing these with schools as they could now be accessed from the website for schools which also included information on SACRE. Positive feedback had been received on the content of the website.

With regards to examination results, more students were opting for the full course and less for the short course.

The Development Plan previously focused on working with schools and to encourage schools to network; resources had been produced for schools and the Agreed Syllabus would undergo a review this year. Mr. Flynn undertook to present a concise development plan to the next meeting.

In response to questions, Mr. Blaylock (R E Today) referred to the primary school network group of approximately 20 representatives and Ms. Maeer had addressed the group to share good practice and her involvement of children in planning R E and strengthening the pupil voice. Ms. Maeer had also agreed to be part of the Agreed Syllabus working group. The network meetings would be taking place as twilight sessions in order to encourage more representatives to attend.

Monitoring within schools had proven difficult; the production units of work had been suspended pending the review of the Agreed Syllabus; the units of work were in addition to SACREs statutory duties.

Mr. Blaylock reported that two meetings of the working group of all phases of school teachers had taken place and their feedback on the sessions was all positive. A questionnaire had been sent to Schools to obtain information on the teaching of R E in schools and training as well as information on the current Agreed Syllabus. Information was also requested on the time schools spent on teaching R E. 45 responses had been received to the questionnaire which had proved to be most helpful. Further working group meetings would be held on 10 September, 2015, 18 November, 2015 and 8 February, 2016 by which time it was hoped that the review of the Agreed Syllabus Conference and SACRE. The working group dates would be included on the website.

Concern was expressed at the budget available to SACRE and felt hat representations should be made to the Council to increase the budget in order to fund the work to be undertaken on the review of the Agreed Syllabus.
