Summary of report

Partnership Plan

To assist with the 12 month review of the partnership plans, it is suggested that each LNP holds a workshop for their area. This will provide an opportunity for the LNP to revisit the current actions in the partnership plan, review the statistical data, and update the information from partner organisations. As a result the LNP will be able to develop a clear set of actions and pledges for the next 12 months that will demonstrate how they are making a difference and having an impact at a local level.'

Feedback from task groups

On the 2nd August a Task group meeting was held at Palfrey CA. Further to the presentation by the portfolio holder Councillor Garry Perry's it was agreed to have a task group meeting on Leisure Provision within the LNP area. Also invited was Jon Lord, from Environmental Regeneration, who spoke about the Statement of Community Involvement, outlining the important role that communities and other key partners play in influencing new plans, policies and planning application in Walsall.

- 'Stop and Search' policy raising awareness of the policy and therefore leading to a better understanding.
- Research commissioned by the Joseph Rowntree Foundation on Prostitution (January February 2006)

LOCAL NEIGHBOURHOOD PARTNERSHIPS TRANSFORMING YOUR SPACE UPDATES

Palfrey and Pleck

Purpose: Inform each LNP on progress on TYS schemes in their area.

Background

A report detailing forthcoming Transforming Your Space (TYS) schemes in the LNPs area was presented and endorsed on 4th October 2004.

Schemes in LNP area

Walsall District Project:

Palfrey Park – new multi-use court, marked out pitch for basketball and 5 aside football, fencing work, new youth shelter and re-alignment of footpath.

Pleck Park – refurbishment of the existing grassed football pitch, new multiuse games area and youth shelter.

Silverdale Park – Play area refurbishment.

<u>Progress</u>

The above schemes have been completed.

Primley Avenue Open Space

Proposal:

- Play area refurbishment.
- New multi-use games area.
- New Skate Park.
- Resurfaced pathway.

Progress

The project has been developed with a local steering group; feasibility work and detailed community engagement have been undertaken.

Changes to Project

Through the development of the project, changes have been necessary. These are:

The play area will now be located in its current position.

- The Multi-use games area will now be located near the entrance at Woodwards Road.
- The skate park element of the scheme was not supported by the local community and has now been removed from the project. However, further entrance and boundary improvements have been included within the proposals to meet the needs of local residents.

<u>Timescale</u>

The timescale for the implementation of the project outlined in the October 2004 report has slipped. The main reason for this is that during the detailed consultation stage many issues arose which needed to be resolved before the project could proceed, for example, the discovery of contaminated land and then the need to re-consult residents due to a location change. Furthermore, procurement issues led to further delays. All issues have now been resolved and the project has been tendered. The revised timescale has not and will not jeopardise the implementation of the project or the funding secured for it.
