68/14 Welcome and Apologies

Each Member of the Area Panel and the Officers present introduced themselves.

Apologies for non-attendance were submitted on behalf of Councillors Rochelle, Bird, Clarke, Douglas-Maul and Flower.

Councillor Andrew raised his concerns about what the future held for Neighbourhood Partnerships and the Area Panel under the new administration. He stated that the Aldridge and Beacon Area Panel had an excellent Area Management Team. There were 2 Neighbourhood Managers who would be returning to their substantive posts at NHS and the new Administration would not be replacing them. Councillor Andrew stated that he was concerned how this would impact on the excellent services provided to the area.

In view of this, Councillor Andrew asked for an update on what plans / what direction the new Administration had for Area Partnerships in the future.

In addition, Councillor Andrew raised concern that proposals were in place to use Starting Point agency staff as temporary replacements for the vacant positions within the Neighbourhood Management Team.

The Chair reiterated Councillor Andrew's comments and advised that the Area Panel Team had undertaken a lot of excellent work in the areas supported by the Panel. A significant amount of local people and community groups had benefited tremendously from the work of the Team and the Panel. Furthermore, he stated that if jobs existed, they should be filled on a permanent basis, not temporarily.

Councillor Hughes advised that is was too easy for the Panel to take a parochial view on the situation. Members were aware of the excellent work undertaken in the areas covered by this Panel. However, they did not know if other areas worked as well or if they were as successful.

The Area Manager clarified that the view of other Area Managers was that their Area Panels worked well. Furthermore, he advised that there was new ASB legislation coming into force next month and that this work would be rolled out through the Neighbourhood Partnerships Team rather than through the police.

Councillor Murray sought the Panel's view on calling for the relevant Cabinet Member to issue a response in relation to the new Administration's intensions for the Aldridge and Beacon Area Panel and Neighbourhood Partnerships as a whole.

Members were in support of this course of action.

Resolved that the relevant Cabinet Member be asked to provide a response on the new Administration's plans for the Aldridge and Beacon Area Panel and Neighbourhood Partnerships as a whole.
